

Worship Plan - Updated Phase 2

1. Communication:
 - a. We continue to communicate updates and changes thru a variety of media including weekly email, website, and social media.
 - b. We will encourage you to take responsibility for yourselves, assess your own risk category, and act within your comfort level. See the CDC guidelines here: [CDC High-Risk Assessment](#).
2. Date:
 - a. We continue to be in Phase 2 - Safer at Home in accordance with Governor Cooper's guidance until further notice.
3. One Worship Service @ 10am
 - a. We have increased our capacity to a max of 150 in the sanctuary, still in accordance with local max capacity guidelines (up to 50% of fire code max capacity). If/when we routinely reach our max capacity, we will open the cafe downstairs as a second location to view/participate in worship during the 10am service.
4. Children:
 - a. There will be No Nursery, Children's Ministry, or Children's Worship available during phase 2.
 - b. Children of all ages are welcome to attend the service.
 - c. We are carefully considering if/when/how we might be able to open the Nursery in a reduced capacity in the coming months.
5. Attendance:
 - a. Registration will be required for all who plan to attend. We will use Registrations on Planning Center to manage our headcount.
 - b. We may offer overflow seating in the Cafe, as able.
6. Masks & Hand Sanitizer
 - a. Masks will be required for everyone in the building, except for those on stage while they are on stage. Masks may be removed while outside if still maintaining proper social distance.
 - b. We will provide disposable masks for those who forget, but encourage members to provide their own.
 - c. We will also provide multiple hand sanitizer stations.
 - d. Children 2 and under should NOT wear a face-covering per CDC guidelines
7. Seating:
 - a. Pews will be marked or roped off in order to maintain proper social distancing.
8. Flow:
 - a. All doors, besides front sanctuary doors, in the building will remain locked. There will be no access to offices, children's rooms, or nursing mom's room, for anyone other than the staff and worship team.
 - b. Prefer bathroom trips be kept to a minimum. However, when needed, occupancy and social distancing will be self-monitored.

9. Sacraments: as determined by the session

10. Worship Guides:

- a. We will use the online Worship Guide during Phase 2. This will also be available online prior to Sunday to be printed at home if desired.

11. Live Streaming:

- a. We will continue live streaming at 10am for the foreseeable future.

12. Offering:

- a. Online giving will continue
- b. You may still mail a check to the office as well
- c. There will be a locked collection box available in the sanctuary to drop your check off in person

13. There will be no coffee or bagels available.
