BAGGAGE ALLOWANCE: INTERNATIONAL FLIGHTS: Before embarking on this tour it is important that each tour member be fully aware of the baggage restrictions. Specifically, each passenger is allowed 1 checked piece not to exceed 50lbs or larger than 62" (L+W+D). One carry-on is also permitted but must be able to fit under the seat or in the overhead bin. Any luggage in addition to this will be subject to excess baggage charges which are charged PER FLIGHT, EACH WAY and currently are \$100 per bag, per flight.

All members of the group **will** be subject to excess baggage charges if they are over the limit.

Please check with American regarding baggage allowance which is subject to change at any time.

TRIP CANCELLATION POLICY: *For refund consideration, cancellation must be made in writing to the trip leader. Our trips have non-cancellation policies and you should **NOT** assume you will be able to obtain a refund from the club for deposits or trip payments.*

If a reservation is cancelled prior to March 29, 2020 – \$100 Cancellation Fee

If a reservation is cancelled after or on March 29, 2020 - Non-Refundable

If cancelled after July 6, 2020 an additional \$75 cancellation fee will be charged by ski.com

If a roommate cancels his/her trip after the first deposit deadline, the SWFL Ski Club will make a reasonable effort to find an acceptable replacement for this person. However, the club is not obligated to find a replacement. The participant is also encouraged to find their own. If an acceptable replacement for you cannot be found – the cancelling roommate's deposit will be used for any non-recoverable expenses i.e. single supplement charges for the remaining skier, etc. prior to any refunds.

Refunds will be issued after all expenses for the trip have been accounted for.

In the event the SWFL Ski Club has to cancel the trip all deposits will be refunded to the participants

OUT OF THE COUNTRY TRIPS:
