**CANCELLATIONS:** Charges for cancellations depend on the date that the written notice of cancellation is received by the tour operator.

**CANCELLATION INSURANCE IS HIGHLY RECOMMENDED.** Premiums start at \$138 for coverage between \$1,500-\$2,000. Coverage between \$2,000-\$2,500 the premium is \$174. Coverage between \$2,500-\$3,000 the premium is \$206 per person. Ask for details.

**ENTRY REQUIREMENTS:** All U. S. Citizens participating in this tour program are required to have a **U. S. Passport valid for at least 6 months beyond the return date of the tour.** Any non-U.S. Citizens participating in this tour must check with the appropriate consulate for all countries being visited and transited, to ensure that they have met all entry requirements. It is the participant's responsibility to be sure that all proper entry requirements are met and that they have all the appropriate documents necessary. **NOTE:** Generally, convicted felons are not admitted to foreign countries.
