### Our Organization

Since 1980, the Domestic Violence Crisis Center (DVCC) has provided counseling and advocacy services for victims of domestic violence and their children. DVCC is the only state-certified agency recognized by the Connecticut Coalition Against Domestic Violence (CCADV) serving the communities of Norwalk, Stamford, New Canaan, Darien, Westport, Weston, and Wilton.

DVCC's role is to help those experiencing any level of domestic violence and assist them in building a safer environment for the well-being of themselves and their families. Our services include housing and financial advocacy, legal advocacy; trauma-informed individual and group counseling; and two safe houses, one in Norwalk and one in Stamford.

All victim services are *free and confidential*, and all services offered are multicultural/multilingual.

Our mission is to provide effective services, support and education for the prevention and elimination of domestic violence across the Connecticut communities of Stamford, Norwalk, Darien, New Canaan, Weston, Westport, Wilton, and beyond.

## **Parking**




