Technical College System of Georgia

Investing in Top Talent Incentive Program

Type: Grant

Deadline: 1/16/2026

The Top State for Talent is a cross-agency initiative to transform how Georgians prepare for and access meaningful careers. Launched by Governor Brian P. Kemp and supported by the General Assembly, this effort focuses on breaking down silos between education and workforce systems, ensuring that every Georgian has access to clear, connected, and high-value pathways, developed in partnership with state agencies, employers, and regional leaders.

The program supports up to 10 apprentices per employer with \$2,000 each to offset training costs. Eligible industries include manufacturing, construction, technology, cybersecurity, transportation, distribution, logistics, and public sector.

Recovery Dislocated Worker Grant (DWG)

Type: Grant

Deadline: Ongoing

When Georgia-Pacific, LLC announced in May that it would be closing its containerboard manufacturing mill in Cedar Springs, Georgia, the news was a major blow for more than 500 employees. Now, thanks to a newly awarded \$1.8 million federal grant, WorkSource Georgia and its partners will have more resources to help affected Georgia workers find new jobs and opportunities.

The funding comes through a U.S. Department of Labor Employment Recovery Dislocated Worker Grant (DWG). This 3-year grant, awarded to the Technical College System of Georgia's Office of Workforce Development, is designed to help local economies recover from large layoffs and closures by focusing on reemployment. Funds will be distributed specifically through WorkSource Southwest Georgia which administers federal workforce development programs for the region and has local access points to serve affected workers.

RD Community Facilities Direct Loan & Grant Program

Type: Loan or Grant

Deadline: Ongoing

This program is open year-round and provides affordable funding to develop essential community facilities in rural areas. An essential community is defined as a facility that provides an essential service to the local community for the orderly development of the community in a primarily rural area, and does not include private, commercial, or business undertakings.

U.S. Department of Agriculture (USDA)

RD Special Evaluation Assistance for Rural Communities and Households (SEARCH)

Type: Technical Assistance

Deadline: Ongoing

This program helps very small, financially distressed rural communities with predevelopment feasibility studies, design and technical assistance on proposed water and waste disposal projects. Eligible applicants include public bodies, non-profits, and federally recognized tribes. Eligible areas include rural areas with no more than 20,000 residents and a median household income below 80% of the state non-metropolitan median household income. U.S. Department of Agriculture (USDA) RD Emergency Community Water Assistance Grants

Type: Grant

Deadline: Ongoing

This program helps prevent damage or restore households and business' access to clean, reliable drinking water in eligible rural areas and towns following natural disasters (including drought, flood, earthquake, tornado, hurricane, disease outbreak, chemical spill/leak/seepage, and more). A federal disaster declaration is not required. Funding can improve the natural environment and encourage manufacturers and other businesses to locate or expand operations. Applications for this program are accepted year-round. Eligible applicants include public bodies, non-profits, and federally recognized tribes. Eligible areas include rural areas with no more than 10,000 residents.

U.S. Department of Transportation (DOT) Federal – State Partnership for Intercity Passenger Rail Grant Program

Type: Grant

Deadline: 2/6/2026

This program provides funding for capital projects that reduce the state of good repair backlog, improve performance, or expand or establish new intercity passenger rail service, including privately operated intercity passenger rail service.

Eligible Projects:

- A project to replace, rehabilitate, or repair infrastructure, equipment, or a facility used for providing intercity passenger rail service to bring such assets into a state of good repair
- A project to improve intercity passenger rail service performance, including reduced trip times, increased train frequencies, higher operating speeds, improved reliability, expanded capacity, reduced congestion, electrification, and other improvements, as determined by the Secretary
- A project to expand or establish new intercity passenger rail service
- A group of related projects as described above
- The planning, environmental review, and final design of an eligible project or group of projects described above

U.S. Department of Transportation (DOT) Economic Adjustment Assistance Program

Type: Grant

Deadline: Ongoing

The Economic Development Administration's (EDA) Economic Adjustment Assistance (EAA) program provides funding for technical, planning, and public works and infrastructure projects in regions experiencing adverse economic changes that may occur suddenly or over time. These adverse impacts may result from a steep decline in manufacturing employment following a plant closure, changing trade

patterns, catastrophic natural disaster, a military base closure, or environmental changes and regulations.

Transportation Infrastructure Finance & Innovation Act (TIFIA)

Type: Loan

Deadline: Ongoing

The Transportation Infrastructure Finance and Innovation Act (TIFIA) program provides credit assistance for qualified projects of regional and national significance. Many large-scale, surface transportation projects - highway, transit, railroad, intermodal freight, and port access - are eligible for assistance. Eligible applicants include state and local governments, transit agencies, railroad companies, special authorities, special districts, and private entities. The TIFIA credit program is designed to fill market gaps and leverage substantial private co-investment by providing supplemental and subordinate capital. Each dollar of Federal funds can provide up to \$15 in TIFIA credit assistance and support up to \$50 in transportation infrastructure investment.

Transportation Infrastructure Finance & Innovation Act (TIFIA) - Rural Project Initiative (RPI)

Type: Loan

Deadline: Ongoing

The Rural Project Initiative is aimed at helping improve transportation infrastructure in America's rural communities. Eligible projects include: Roads, bridges and tunnels; Transit systems including infrastructure, bus and train stations, and buses and passenger rail vehicles and facilities; Intermodal connectors; Pedestrian and bicycle infrastructure; Freight transfer facilities; Sea and inland waterway ports, and even; Airports - under certain circumstances. For the purposes of this initiative, a rural project is one that is located outside of an urbanized area with a population greater than 150,000 individuals as determined by the Bureau of Census.

The Office of Brownfields and Land Revitalization is announcing the availability of \$107 million dollars for approximately 36 cleanup grants. Cleanup Grants provide funding to carry out cleanup activities at brownfield sites owned by the applicant. The goal of the grant program is to clean up contaminated properties with the aim of facilitating their sustainable reuse.

Airport Terminals Program

Type: Grant

Deadline: 1/15/2026

Through the Infrastructure Investment and Jobs Act, a total of **\$5 billion has been allocated (\$1 billion annually from 2022-2026)** to provide competitive grants for airport terminal development projects that address the aging infrastructure of the nation's airports. These grants will fund safe, sustainable and accessible airport terminals, airport-owned airport traffic control towers, and on-airport rail and bus projects that improve multimodal connections, ensuring a safe and seamless travel experience for families across the U.S.

South Arts

Professional Development Grants for Arts Organizations

Type: Grant

Deadline: 6/30/2026

South Arts strongly believes that skill and knowledge building for arts organizations are integral to success and sustainability. These grants are designed to support the professional development needs of Southern arts organizations for increasing organizational capacity to achieve long-term sustainability, growth, and/or operational stability. This grant program is open to film, visual arts, performing arts, traditional arts, literary arts, and multidisciplinary arts organizations.

Funding can support staff or board participation at conferences, workshops, and other professional development opportunities and events. In addition, these grants can support expenses for in-person and virtual professional development for organization-wide staff learning and training. Funds support travel expenses (for example, lodging and air/ground transportation), admission/registration fees, or other related expenses (for example, consultant/service fees for staff learning/training sessions).

Better Buildings Challenge

Type: Technical Assistance

Deadline: Ongoing

The Better Buildings Challenge is a voluntary leadership initiative that asks leading CEOs and executives of U.S. commercial and manufacturing companies, universities, school districts, multifamily residential organizations, data centers, and state and local governments to make a public commitment to energy efficiency.

Eligible Partners: Partners are commercial businesses, industrial corporations, data centers, universities, states, municipalities, and other building owners that make a public commitment to reduce energy consumption across their U.S. portfolios. Seed Grant Program

Type: Grant

Deadline: Ongoing

Community Heart & Soul is a resident-driven process that engages the entire population of a town in identifying what they love most about their community, what future they want for it, and how to achieve it. The Seed Grant Program provides start-up funding for resident driven groups in small cities and towns looking to implement the Community Heart & Soul model. Grant funding of \$10,000 requires a 1:1 cash match. Eligible uses includes:

National Endowment for the Humanities

Rediscovering Our Revolutionary Tradition

Type: Grant

Deadline: 1/15/2026

The Rediscovering Our Revolutionary Tradition program supports activities to preserve and improve access to primary source materials—including archival records; documents and rare publications; art and material culture; and photographs and sound recordings that document:

1) The history of American independence and establishment and/or expansion of the nation, including the experiences of states, territories, and communities—in the original colonies and beyond—joining the nation; or, 2) The history of American government in federal, state, and local contexts, including the federal Constitution, the Bill of Rights, the Declaration of Independence, state constitutions, governors' papers, charter documents, court and legislative records, and other foundational documents.

Applications may be submitted for projects that address one or more of the following activities:

- providing conservation treatment for and/or rehousing original items or groups of items;
- cataloging or arranging and describing collections of archival records, documents, and rare publications; art and material culture; and photographs, sound recordings, and other primary sources;
- digitizing collections and making them available for public use through websites, portals, or local, state, or national repositories;
- using advanced imaging and associated data to promote the research value of primary sources;
- transcribing or translating primary source materials, including through crowdsourced means;
- updating previously digitized resources to improve access and preserve digital surrogates or other digital assets; and

- developing indexes, databases, or other project-specific digital resources to codify information on a subject or to aggregate selected humanities materials.

CDBG Section 108 Loan Guarantee Program

Type: Loan Guarantee

Deadline: Ongoing

The CDBG Section 108 Loan Guarantee Program is an economic and community development financing tool authorized under Section 108 of Title I of the Housing and Community Development Act of 1974, as amended. The program is a method of assisting non-entitlement local governments with certain unique and large-scale economic development projects that cannot proceed without the loan guarantee. In order to be eligible a project must meet all applicable CDBG requirements and result in significant employment and/or benefit for low and moderate income persons. Projects that are eligible for financing under existing federal, state, regional or local programs will generally not be considered for guarantee assistance unless the programs would fail to fully meet a project's need.

Downtown Development Revolving Loan Fund (DDRLF)

Type: Grant to Lenders (grants for DDAs to lend to businesses)

Deadline: Ongoing

The purpose of the Downtown Development Revolving Loan Fund (DDRLF) is to assist cities, counties and development authorities in their efforts to revitalize and enhance downtown areas by providing below-market rate financing to fund capital projects in core historic downtown areas and adjacent historic neighborhoods where DDRLF will spur commercial redevelopment. Eligible applicants under this program shall be municipalities with a population of 100,000 or less, counties with a population of 100,000 or less proposing projects in a core historic commercial area, and development authorities proposing projects in a core historic commercial area in municipalities or counties with a population of 100,000 or less. The ultimate user of funds may be a private business or a public entity such as a city or development authority.

Redevelopment Fund (RDF)

Type: Grant or Loan (Flexible Financial Assistance)

Deadline: Ongoing

Recognizing that redevelopment projects can be the most challenging economic and community development projects a local government may undertake, the Redevelopment Fund (RDF) was created as a set-aside of Georgia's non-entitlement CDBG Program. The RDF provides local governments access to flexible financial assistance to help them implement projects that cannot be undertaken with the usual public sector grant and loan programs. The RDF finances locally initiated public/private partnerships to leverage investments in commercial, downtown, industrial redevelopment, and revitalization projects that may not proceed otherwise. Unlike other DCA CDBG programs, the RDF uses the CDBG national objective of "eliminating slums or blight." As a result, many smaller scale projects (in downtown areas or blighted industrial areas) may be competitive for RDF financing.

Type: Technical Assistance

Deadline: Ongoing

The Downtown Renaissance Strategic Visioning and Planning Process assists downtowns through the creation of a community-supported vision, plan, and implementation program. The RSVP is both a downtown master planning process and a downtown planning document that illustrates the community's vision for the future and provides the steps to get there. Driven by a robust public input process that seeks the participation of all community members, RSVPs help local governments and community partners prioritize top downtown issues and work to establish a consensus around what must be achieved in the short and long-term.

State Small Business Credit Initiative (SSBCI)

Type: Loan

Deadline: Ongoing

The Small Business Jobs Act of 2010 (the “Act”) became law in the fall of 2010. The Act created the State Small Business Credit Initiative, funded with \$1.5 billion to strengthen state lending programs that support small businesses and manufacturers. Of the total amount funded, Georgia was allocated \$48,024,748. Currently, Georgia’s SSBCI offers two programs.

1. GA LPP (Georgia Loan Participation Program) is a program where the State purchases a participation of up to 25% of an approved loan, for loans ranging from \$100,000 to \$5,000,000.
2. Georgia SBCG (Small Business Credit Guaranty) is a 50% loan guaranty program with a current maximum loan amount of \$400,000 with a \$200,000 guarantee.

The Center for Economic Development Research at Georgia Tech's Enterprise Innovation Institute will be funding a new round of Economic Development Research Program (EDRP) projects and is looking for communities to submit their applications for research. The mission of EDRP is to assist local communities by providing affordable economic development and policy research to enhance their competitive positions. The types of research include strategic planning and visioning, economic forecasting, fiscal and economic impact analysis, community assessments, downtown development planning, and workforce analysis and planning to name a few. If your community has a need for economic development research, is willing to become actively involved in the project during the study phase and follow-up implementation, and is willing to provide some level of cost match, Georgia Tech and EDA want to partner with you to conduct the research. There are limited funds available and projects will be chosen based on local commitment, likelihood of implementation, level of cost match, and obviously a match with the capabilities of the research team at Georgia Tech. We look forward to getting your applications and partnering with you to meet your community's research needs.

U.S. Chamber of Commerce CO-100 2025

This grant is open to all small business owners who are U.S. residents and run a for-profit business that has been in operation for at least one year. One winner receives a \$25,000 grant. Ten additional businesses also receive \$2,000 grants. Applications for the 2025 cycle open in the spring.

South Arts Arts in Rural Places

Type: Grant

Deadline: 6/30/2026

South Arts believes that rural, isolated, and small communities deserve access to the arts, and this requires specialized support to make that vision viable. Distributed on a first-come, first-serve basis, Arts in Rural Places Grants support rural and isolated communities (communities that are geographically isolated or isolated due to socioeconomic factors, outmigration, education gaps, and/or lack of infrastructure) as well as small cities with populations of 50,000 people or less with expedited grants of up to \$3,000.

Arts in Rural Places Grants are an opportunity for organizations in South Arts' nine-state region to receive artist fee support to engage Southern guest film directors, traditional, visual, and performing artists, or writers from inside or outside of the presenter's state. Artist fee support is awarded for:

- film (documentary, fiction, experimental, and animation),
- traditional arts (music, dance, storytelling, and visual arts/crafts),
- visual arts (crafts, drawing, experimental, painting, photography, sculpture, and mixed media),
- performing arts (theater, music, opera, musical theater, and dance), and
- literary arts (fiction, creative nonfiction, and poetry).

Projects require at least two public-facing activities that offer access to arts programming by Southern artists (this can include public performances, screenings, readings, exhibitions, workshops, demonstrations, lectures, facilitated discussions, and/or master classes). Based on the artist fee, the maximum request is \$3,000. The grant requires a dollar-for-dollar cash match (for example, an applicant that requests \$3,000 must provide a \$3,000 cash match for a project with a \$6,000 artist fee).

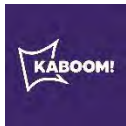
