General Overview of Course:

This is a four-day theory and applications course for application of thermal imaging for Preventive/Predictive Maintenance, Condition Monitoring, Quality Assurance and Forensic Investigations.

This course meets training requirements for third-party certification of Non-Destructive Testing (NDT) personnel in the Thermal/Infrared Methods in accordance with the American Society of Non-Destructive Testing (ASNT) document SNT-TC-1A.

Price for this course includes all materials, trial version of Exception® report generation and information management software. The written exam is offered at the end of the course. Infraspersion Institute Certified Infrared Thermographer® Level-1 Certification is issued to all students scoring 80% or higher on the written exam.

Craig Preston is a Level II Thermographer, Level 1 and 2 Certification for Air Leakage Testing, and Buildings Science Principles Certificate. He holds a degree in Electromechanical Engineering.

For the past 19 years he has managed a power plant of a municipal utility system, maintaining generator units of 2.5 to 19 megawatts. He was also project manager of the rehabilitation of a 5 megawatt hydroelectric plant and construction of a distribution substation.
