Nosimilo has also contributed to fostering a culture of human rights through research, writing papers, public education, lobby and advocacy. Nosimilo holds a Bachelor of Law Degree and a Master's Degree in Development Studies.

### *Mr. Jade Tsokodai – Financial Advisor*

Mr. Jade Tsokodai is an entrepreneurial Chartered Accountant with over 10 years of experience in advisory, financial reporting and external auditing in the financial services sector as well as in other sectors such as agriculture, manufacturing, energy, construction and non-governmental organisations (NGOs).
