

## San Luis Obispo County Ag Pass Card Application



Ag Pass cards will be issued before an emergency, not during. It will be limited to a maximum of 3 people per property; all of whom must participate in the required training. Ag Pass ID card possession does not grant any rights or privileges and does not guarantee access to the property. Imminent danger will negate access, ensuring protection to emergency crews and public from unnecessary exposure to risk which can happen if civilians enter dangerous zones and require rescue or protection.
