## DPR seeks public input on pesticide applications


The California Department of Pesticide Regulation will hold three public workshops in late June to collect feedback to inform the next phase of design and development for the state's pesticide application notification system.

California will be the first state to develop a system to provide the public more transparent and equitable access to information in advance of pesticide applications. Virtual workshops will be held on Zoom from 1 to 3 p.m. on June 27; 10 a.m. to noon on June 28; and 6 to 8 p.m. on June 29.

Workshops will feature an overview of the proposed design for the statewide notification system and an opportunity for the public to provide input. Registration is not required to attend.
