The Louisiana Credit Union League (LCUL) is excited to award **partial** scholarships to the [Southeast CUNA Management School](#) in Athens, Georgia. This year's program is being held **June 5–12, 2020**.

### ***About the Southeast CUNA Management School***

The mission of the Southeast CUNA Management School is to provide students the opportunity to develop their leadership capabilities. Students leave the school with meaningful, long-lasting relationships with classmates that strengthen the cooperative nature of the credit union movement.

The Southeast CUNA Management School is held at the University of Georgia's Conference Center and utilizes faculty from the University's Terry College of Business as well as industry experts. It is a three-year curriculum where students participate each summer for eight days. Throughout the year, students apply their knowledge to projects that require strategic analysis of their credit union and research relevant issues facing the industry.

### ***Scholarship***

The Southeast Regional Credit Union Schools (SRCUS) Scholarship is based on current and potential involvement in the credit union movement. Recipients of this scholarship receive funding to help defray the cost of tuition for the current year; recipients must reapply each year. *Funding for this scholarship program is provided by LCUL and SRCUS.*

### ***Qualifications & Requirements***

The scholarships are open to all professionals from League-affiliated credit unions. Applicants applying for the scholarships are required to provide the following:

- This completed application form (see page 2)
- Letter of recommendation from applicant's credit union supervisor or official

### ***Deadline***

Completed scholarship applications, along with required letter of recommendation, must be submitted by **March 31, 2020**. Scholarship recipients will be notified by April 10, 2020.
