Nine Reasons to Love Kamala Harris

COURTS DOMINATED BY PRO-ABORTION ACTIVISTS

Biden will take a page out of Trump’s playbook and stack our federal courts with pro-abortion judges. Pro-life advocates have fought for years to pass laws which have ultimately landed in the court system. Many pro-life laws are still there, awaiting judgment. The leaders in the pro-life movement believe that our next life battle is actually in the courtroom where we make the case for our pro-life laws to take effect. In Biden’s America, we will lose those battles, and decades of hard work by devout pro-lifers will simply be lost forever. **This presidential ticket has gone on record stating that their judicial nominees will support *Roe v. Wade*.**

ROE V. WADE CODIFIED INTO LAW

One of the worst fears of the pro-life movement is that *Roe v. Wade* becomes a federal law, required to be followed by all citizens in all states. According to his own campaign website, Biden says he will, “**...work to codify *Roe v. Wade*, and his Justice Department will do everything in its power to stop the rash of state laws that so blatantly violate *Roe v. Wade*.**”ⁱ Furthermore, Harris has committed to enact a regime of “preclearance,” that would block state laws that her administration deems contrary to *Roe v. Wade*.

ABORTIONS PAID FOR WITH YOUR HARD EARNED MONEY

Although Biden has supported the Hyde Amendment throughout his political career, he changed his tune in June 2019, saying, “If I believe health care is a right, as I do, I can no longer support an amendment that makes that right dependent on someone’s zip code.”ⁱⁱ The Hyde Amendment forbids most taxpayer dollars from funding abortions except in cases of rape, incest, or to save a mother’s life. According to the Charlotte Lozier Institute, since 1976, the best research indicates that the Hyde Amendment has saved over two million unborn children. Biden will get rid of it entirely, forcing you to pay for the abortions of your fellow citizens. Worse than this though, according to his campaign website, **Biden says he will restore federal funding for Planned Parenthood by not permitting states to refuse them Medicaid funding, and giving them access to federal family planning dollars that have been eliminated by the Trump administration.**

MILLIONS MORE DEAD BABIES

Kamala Harris believes in increased “access to abortion”. As a senator, she has voted against abortion bills that protect preborn babies after 20 weeks, and refused to vote to protect babies born alive after attempted abortions. When Kamala Harris was announced as Biden’s running mate, Planned Parenthood stated, “With this selection, Joe Biden has made it clear that he is deeply committed to not only protecting reproductive rights, but also *advancing and expanding them*.” The Biden-Harris team has been endorsed by Planned Parenthood who recently posted a webpage entitled, “**Nine Reasons to Love Kamala Harris**”ⁱⁱⁱ. Biden also publicly announced that abortion is “essential” during the pandemic. **Furthermore, they will make the abortion pill available over the counter, resulting in women giving birth to dead babies in toilets at home, in their dorms, in public restrooms, and the like.** There should be no doubt in anyone’s mind that the abortion rate will rise under a Biden administration.

PRO-LIFERS PERSECUTED

Joe Biden will completely remove conscience protections. He will have the Little Sisters of the Poor back in court for refusing to pay for contraceptives. When Kamala Harris was Attorney General of California, she targeted David Daleiden whose only crime was that he exposed the truth about Planned Parenthood harvesting and selling the parts of aborted babies for profit. Instead of investigating Planned Parenthood (who was donating to her campaign at the time), Harris raided Daleiden’s home and seized copies of the undercover videos. Also, as Attorney General, Harris sponsored a bill that required pro-life pregnancy centers in the state to give their clients information about where to access abortions. (Fortunately, the law was struck down by the Supreme Court.) **There will be no place for pro-life people in the Biden-Harris America, and we will be persecuted for our stand for life.**

The **PATH OF LIFE** will keep our country on a trajectory headed towards overturning *Roe v. Wade*, completely defunding abortion, and establishing absolute protection for the most vulnerable people. This path leads to:

OVERTURNING ROE V. WADE

President Trump has appointed over 200 pro-life judges to the federal judiciary, including two Supreme Court Justices. Even CNN reported on this saying, **“Trump...has significantly reshaped the judiciary during his first term, and the 200th appointment milestone illustrates how lasting his legacy will be, as federal judges serve lifetime appointments and many of Trump’s picks have been young judges who can serve for many years.”**^{iv} We can expect more of the same in a second term. Although the timeline is unknown, ultimately *Roe v. Wade* will be overturned by judges who respect both God’s law and the Constitution of the United States.

AMERICAN CITIZENS NO LONGER PAYING FOR ABORTION

President Trump has eliminated taxpayer funding of abortion overseas in ALL global health spending, not just family planning dollars. The Trump policy protects over \$8.8 billion in aid from funding abortion overseas.^v President Trump set new rules on family planning dollars in the federal budget. He has also permitted states to prohibit Medicaid funding of Planned Parenthood, something the pro-life movement has been driving for decades. Furthermore, under President Trump, HHS issued a new rule requiring insurance companies to be transparent about their policy coverage of abortion. They have also issued mandates for conscience protections for groups like the Little Sisters of the Poor to exempt private employers and educational institutions from providing or paying for contraceptives and other abortifacient drugs.

ETHICAL GOVERNMENT FUNDED SCIENCE

The Trump administration recently built the Human Fetal Tissue Research Ethics Advisory Board to make recommendations on 14 different research proposals utilizing human fetal tissue. The board recommended to HHS that 13 of the 14 proposals be denied due to unethical methods. **Pro-lifers’ cries against the desecration of aborted baby bodies have fallen on deaf ears until now.** This type of oversight and moral standard will continue under a second term of President Trump.

THE UNITED STATES FIGHTING ABORTION INTERNATIONALLY

President Trump’s State Department cut out taxpayer funding to the United Nations Population Fund, an organization strongly supportive of China’s gruesome population control techniques. The President has been an outspoken opponent of abortion at the UN, saying in his remarks to the General Assembly in September 2019, “We are aware that many United Nations projects have attempted to assert a global right to tax-payer funded abortion on demand, right up until the moment of delivery. Global bureaucrats have absolutely no business attacking the sovereignty of nations that wish to protect innocent life. Like many nations here today, we in America believe that every child, born and unborn, is a sacred gift from God.”^{vi} Furthermore, the administration has instructed officials to amend any UN resolutions that include the terms “sexual and reproductive health”, since these are gateways to abortion on demand and explicit sexual education programs worldwide.

THE PRO-LIFE VOICE AND WAY OF LIFE PROTECTED

President Trump issued an executive order in June to bolster America’s foster care and adoption programs, including increasing partnerships with faith-based organizations. He has protected faith-based adoption. He has defended pro-life students’ right to free speech by threatening to pull federal funds from colleges that violate the first amendment. Furthermore, the administration recently finalized a new rule clarifying that the federal definition of sex discrimination under Obamacare does not include abortion. These types of protections enable pro-lifers not only to live our beliefs, but also to help us inspire a true a culture of life.
