TERMS AND CONDITIONS

1. Promotion Details

By entering this Prize Draw (the “Prize Draw”) you agree that you have read and understood these Terms and Conditions and agree that you will be bound by them. These Terms and Conditions govern your relationship with Badlands , whose address is Badlands, 11 St. George’s Place, Cheltenham GL50 3LA (“Badlands”) and is in no way sponsored, endorsed, administered or associated with Twitter or Facebook or Instagram or Spotify. These Terms and Conditions and the terms and conditions of Twitter <https://twitter.com/tos> and the terms and conditions of Instagram <http://instagram.com/about/legal/terms> and the terms and conditions of Facebook <http://www.facebook.com/policies/?ref=pf> and the terms and conditions of Spotify <https://www.spotify.com/uk/legal/end-user-agreement/plain/> and all other information provided prior to entering the Prize Draw form part of the rules of entering this Prize Draw (the “Rules”). By entering the Prize Draw you agree that you have read, agree to and are bound by the Rules.

2. Participation

- 2.1 The Prize Draw will run from Midday BST on Friday 5th June 2020 (the “Starting Date”) and the “Closing Time” will be 23:59 BST on Wednesday 24th June 2020 (the “Closing Date”) (collectively the “Prize Draw Period”). For the avoidance of doubt no entries will be counted before or beyond the Prize Draw Period.
- 2.2 To enter this Prize Draw you are invited during the Prize Draw Period to **fill in the Prize Draw form** with your details (the “Entry”). Send your Entry for a chance to win **a white label 12” vinyl test pressing** (“the Prize”). There is 1 (one) Prize available. The prize was given to Badlands by Bob Dylan’s record label Sony entertainment.
- 2.3 Entry is open to all Badlands customers and **you must be aged 14 years old or over** (as of the Starting Date) to enter this Prize Draw. **If you are under 14 years old, your entry will be disqualified.** **If you are aged 14, 15, 16 or 17 you must have the permission of your parent or legal guardian before entering this Prize Draw and submitting an Entry.** If you are 18 years old, or over, you are eligible with no permissions required.
- 2.4 Badlands (and its licensees, affiliates and assigns) reserves the right to cancel the Prize Draw or amend these Terms and Conditions without notice in the event of circumstances outside its control, including without limitation, a major catastrophe, war, civil or military disturbance, strike, flood, earthquake or any actual, anticipated or alleged breach of any applicable law or regulation or any other similar event. No liability shall attach to Badlands as a result thereof. If a sufficient number of eligible Entries (as

determined by Badlands, in its sole discretion) are not received by the end of the Prize Draw Period, Badlands reserves the right not to award the Prize.

- 2.5 Employees and their immediate families of Badlands, companies within Badlands group of companies and any of their subsidiaries and/or agencies associated with this Prize Draw are ineligible to enter. Any such entries will be invalid.
- 2.6 You may not submit more than one (1) Entry to this Prize Draw. Any duplicates will be deleted and you may be disqualified from this Prize Draw.
- 2.7 Your standard telephone, internet, network and data charges will apply (there is no additional charge to enter this Prize Draw) and you must have the bill payer's permission prior to entering the Prize Draw.

3. Submitted Material

- 3.1 By entering the Prize Draw you warrant and represent that your Entry does not and shall not contain any material that, in Badlands sole discretion (including but not limited to): (i) impersonates any person or entity, or falsely states or otherwise misrepresents your affiliation with a person or entity, without such person or entity's prior written consent; (ii) constitutes personally identifying information or other personal or identifying information about you or any individual; (iii) is false, deceptive, misleading, scandalous, indecent, criminally obscene, pornographic, unlawful, blasphemous, defamatory, libelous, fraudulent, tortuous, threatening, harassing, hateful, degrading, intimidating, or racially or ethnically offensive, or contains nudity, pornographic images, explicit sexual themes or graphic violence; (iv) encourages conduct that could be considered a criminal offense, could give rise to criminal civil liability, or could violate any law, or that could otherwise be considered inappropriate; (v) constitute a virus, worm, Trojan horse, Easter egg, time bomb, spyware, or other computer code, file or program that is harmful or invasive or may, or is intended to damage or hijack the operation of, or to monitor the use of, Badlands or any hardware, software, or equipment; (vi) constitutes any advertising, promotional material, or other form of solicitation; or (vii) constitutes any non-public information about a company.
- 3.2 Badlands may at its sole discretion opt not to use, without notice or reason, any Entry that Badlands believes is inappropriate or in breach of these Rules or if it simply does not wish to use them.

4. The Prize

- 4.1 i) at the end of the Prize Draw Period, 1 (one) Entry will be randomly selected by Badlands (at Badlands sole discretion) from all the eligible Entries to win the Prize (referred to herein as a "Winner").
 - ii) In the event that a Winner is not, or is unable to, comply with and meet the Rules, Badlands shall be entitled at its discretion to disqualify such Winner, without any further liability to that person. No liability shall attach to Badlands as a result thereof.

- iii) No cash alternatives shall be available for the Prize. The Prize is non-transferable. However, Badlands reserves the right to change the Prize at its discretion or to offer an alternative Prize.
- 4.2 The Winner will be contacted via an email from Badlands to the email address provided on their Entry. Once notified the Winner must provide Badlands with their full name and home postal address to receive the Prize. The Winner may, in Badlands absolute discretion, be required to sign all necessary waivers, consents, or permissions of any nature required by Badlands together with an agreement ratifying the rights granted to Badlands herein (and any other documents reasonably required by Badlands) (the "Required Agreement(s)"). **If a Winner cannot be contacted within forty eight (48) hours** of first notification attempt, or if a Winner rejects the Prize, or if a Winner's home address or email returns as "undeliverable", or if a Winner's telephone/mobile does not work, then Badlands reserves the right, at its sole discretion, to disqualify such Winner without any further liability to that person and offer the Prize to another entrant selected by Badlands (at Badlands sole discretion) from all remaining eligible Entries and thereafter until another Winner is found. In the event that a Winner is unable for whatever reason to accept the Prize, or in the event of non-compliance with the Terms and Conditions, or if the Required Agreement(s), if required, is/are not properly executed, Badlands shall be entitled at its discretion to disqualify such Winner, without any further liability to that person and the Prize will be forfeited and an alternative Winner may be selected by Badlands (at Badlands sole discretion) from all remaining eligible Entries. Upon Prize forfeiture, no compensation will be given. You agree to comply fully with each provision in the Rules.
- 4.3 For the avoidance of doubt, any expenses not specified in these Terms and Conditions are the sole responsibility of the Winner.
- 4.4 The Prize will be sent either via mail recorded delivery or courier to the Winner. Badlands does not accept any responsibility for the delivery of the Prize and/or the mail service and/or courier service.
- 4.5 In all cases Badlands (and its licensees, affiliates and assigns) shall not be liable for any email notification that does not reach a Winner for reasons beyond Badlands (and its licensees, affiliates and assigns) reasonable control. Badlands (and its licensees, affiliates and assigns) shall not be responsible for any costs or losses incurred directly or indirectly by a Winner as a result of an incorrect email address given by such Winner.
- 4.6 Badlands (and its licensees, affiliates and assigns) accepts no responsibility for entries lost, damaged or delayed, or for any difficulty experienced in accessing or submitting your Entry. Late, damaged, defaced, illegible, incomplete or suspected fraudulent entries will not be accepted. Proof of dispatch of the Entry (whether electronic or postal) will not be accepted as proof of receipt by Badlands.
- 4.7 Details of the Winner will be available on request to all participants who send a stamped addressed envelope to Badlands at the address below.

5. General Terms

- 5.1 Badlands reserves the right to verify the eligibility of your Entry. Badlands may request that the Winner contacts Badlands to confirm that they are the winning entrant and/or to provide proof of identity, age and residency. In the event of a dispute as to the identity of the person who submitted an Entry, any Entry will be deemed to have been submitted by the authorised holder of the email address provided on the applicable Entry. A Winner may be requested to provide Badlands with proof that they are the authorised holder of the email account associated with a winning Entry.
- 5.2 Entries that are incorrect or incomplete will be void. No refund will be made for the cost of any Entry. Badlands may refuse to award the Prize, or withdraw the Prize, in the event of your fraud, dishonesty or non-entitlement under the Rules.
- 5.3 Each Winner may be required, as a condition of being awarded the Prize, for no remuneration, to participate in promotional and publicity materials at the reasonable request of Badlands and it shall be a condition of being awarded the Prize that such Winner must consent and agree to do so.

right in its sole discretion to modify these Rules and/or to cancel, terminate, modify, or suspend the Prize Draw.

- 5.8 You hereby agree to release and hold harmless Badlands, its parent companies, affiliates, subsidiaries, divisions, advertising and promotion agencies and its respective employees, officers, directors, agents, representatives, shareholders and Prize' partners (collectively, the "Releasees") from any claims, actions, injury, loss or damages of any kind, including but not limited to, any damage to the entrant's or any other person's computer relating to or resulting from participation in, or downloading of any materials or software in connection with, this Prize Draw, personal injury or death (except for liability for death, personal injury and damage or loss caused by negligence by Badlands, which is not excluded) resulting from participating in this Prize Draw or from the acceptance, possession, or use or misuse of any Prize awarded or participation in any Prize-related activity. - 6.1 The Winner agrees to keep confidential any knowledge about the Artist and/or Badlands and its business and personnel received by such Winner as a result of their Prize (including without limitation not sharing private details on social media).

- 6.3 For the avoidance of doubt Badlands will be the data controller and data processor of the personal data collected from you and/or third parties in order to enter you into the Prize Draw and to include you on its mailing list if applicable.
