Improve the profitability of your operation by developing a positive income stream from marginal ground.

CREP provides rental payments for ground devoted to conservation cover for 10 to 15 years.

CREP provides cost shares for establishment and mid-contract maintenance.

Reduce erosion on steep fields and eroding stream banks by growing conservation cover.

Improve water quality by fencing animals out of streams and wetlands and developing an alternative water source.

Develop wildlife habitat for birds, mammals, reptiles, amphibians, pollinators too!

CREP may be a fit for your eligible cropland and marginal pastureland along non-forested streams.

Animal operations can learn how this program fits into manure management planning.

Common Conservation Practices:
Conservation Cover on marginal cropland which can include native warm season grasses with wildflowers or introduced grasses.

Riparian buffer along non-forested stream.

Wetland Buffer.

Grassed Waterway.
