

# NOMINATIONS – JANUARY 26, 2020

## Elders

*Elders comprise the Session of the Presbyterian Church which is, in essence, the decision-making body of the church. They recommend and approve all program and policy implementation and modifications in the church. Elders serve a three year term and the Session meets monthly; Elders generally serve on one or more committees, which also usually meet on a monthly basis.*

### **Ben Coleman**

Ben and his wife Lauri have two children, Seth, 16, and Sharon, 13; they live in Bethlehem. The family has been involved at FPCB for 12 years; the Coleman children went through the choirs and Sunday school programs; Ben participated in a men's breakfast group and currently rings in the handbell choir. They attend the Traditional service (yay for organs and hymns!). Ben is a professor of Computer Science at Moravian College and is on the board of the Blue Mountain Jeep Alliance.

### **Mark Ferguson**

Mark and his wife Tammy have two sons, Maxwell and Samuel. He joined FPCB when he was in high school; his father was a minister at First Pres from 1970-1986 and his mother has served as a Deacon. After some time away, he rejoined the congregation during the schism and has been an active member of the choir for three years. Mark was on the Board of Directors of the Lehigh Valley Charter High School for the Arts, where Dave Macbeth is on the faculty. ## Deacons

*The **Deacons** are the caregivers of the church. They minister to the individual members through home communion and visits, hospital and prayer ministries, and providing support to those in difficult situations. Deacons serve a three year term and typically meet monthly.*

### **Jeff Csatari**

Jeff and his wife Kathy are residents of Hanover Township, and have been members of FPCB for 26 years. They have three daughters: Katelyn, 25, Lydia, 22, and Sophia, 13. Jeff served as a deacon ten years ago, and also has been an usher. ### **Barbara Hjorth**

Barbara and her husband Rich joined the church in 2011. She has participated in the traditional worship service as a liturgist, has served communion, and is a member of the chancel choir. ## **Nominating**

*The Nominating Committee members are charged with identifying candidates for Elders, Deacons, Trustees, and the Nominating Committee itself. This committee usually meets three or four times each year; the term of service is one year, and a member may serve no more than two consecutive terms.*

### **Matthew Cascioli**

Matt, a Salisbury Township resident, is married and has two sons who also attend FPCB. For 15 years he has served as an usher, and currently he works the computer at the Contemporary service and participates as a reader. Matt is a member of two community bands, one of which has appeared at FPCB many times. He is a retired school teacher and currently serves part time as the secretary/treasurer of AFM Local 45. Writes Matt: "I would like to serve because I feel a strong commitment to helping the church maintain its status as a Christian place of worship where all are made to feel welcome, to come as they are."

## **Trustees**

*Trustees oversee all financial and property matters in the church including the budget, building renovations and repairs, planned giving, and investment funds. Trustees will meet monthly and members will also serve on one additional committee, such as the property or finance committee, which also generally meet monthly. The term for Trustees is three years. Because the Board of Trustees is being newly established, nominees will initially be asked to serve one, two, or three years.*

### ***Alexander "Pat" Dyer (one year term)***

Pat, a resident of Kirkland Village, has been a member of this church for over 50 years; he and his wife Shirley and raised their two children, David and Steven, at FPCB.
