President shall serve as chairman of the board and shall be responsible for program planning, and shall assemble information and data and cause to prepare special reports as directed by the program of the chamber.

The President shall be a member of the Board of Directors, the Executive Committee, and all Committees.

President Elect shall exercise the powers and authority and perform the duties of the President in the absence or disability of the President. The duties of the President Elect shall include those that may be assigned by the President and Board of Directors. There shall be a Vice President heading each of the standing committees.

A member of the Board of Directors who is absent form 3 consecutive regular meetings of the Board shall automatically be dropped from membership of the Board unless overcome due to illness or other business requirements.

The Board of Directors shall be composed of 15 members. Seats are two 2 year terms, with a maximum period of consecutive service of 4 years.
