

## NATUREWALK HOA & CDD ROLES

The NatureWalk Community Development District (CDD), not the NatureWalk Homeowners Association (HOA), operates and manages many things the HOA is contacted about.

The NatureWalk CDD has an elected board and is a special-purpose governmental entity with its Board of Supervisors and the power to levy non-ad valorem assessments. They are responsible for maintaining the infrastructure within the District and repayment of the bonds utilized for the construction and/or acquisition of the public infrastructure. The NatureWalk HOA works closely with the CDD through the Common Area & Grounds (CAG) Committee on joint projects such as the Radar Speed Limit sign. An excellent resource for understanding the different areas in NatureWalk is the Walton County Assessors Map [link].
