Anthem Quality Measure Definitions



Appropriate Testing for Pharyngitis (CWP) This HEDIS measure looks at the percentage of episodes for members 3 years of age and older who were diagnosed with pharyngitis, dispensed an antibiotic, and received a group A streptococcus (strep) test for the episode. Code services correctly; use the following codes to identify pharyngitis and strep tests:

Asthma Medication Ratio (AMR) This HEDIS measure looks at the percentage of members 5 to 64 years of age with persistent asthma who had a ratio of controller medications to total asthma medications of 0.50 or greater during the measurement year. Use the following codes to appropriately document asthma:

Avoidance of Antibiotic Treatment for Acute Bronchitis/Bronchiolitis (AAB) This HEDIS measure looks at the percentage of members 5 to 64 years of age with persistent asthma who had a ratio of controller medications to total asthma medications of 0.50 or greater during the measurement year. Code services correctly, Use the following codes to identify acute bronchitis:

Well Child Visits – 6 or more with a PCP before turning 15 months old – visits must be at least 2 weeks apart. This HEDIS measure looks at the members who had the recommended number of well visits. Code services correctly, proper coding is critical to ensure accurate reporting of these measures.

Well Child Visits – 3 to 6 years old with a PCP before turning 15 months old – visits must be at least 2 weeks apart. This HEDIS measure looks at the members aged 3-6 years who had at least one comprehensive well-care visit with a PCP during the current year. Code services correctly, proper coding is critical to ensure accurate reporting of these measures.
