Luke chapter 10 speaks highly of the Samaritan who cared for a man who was attacked and was left wounded on the road. • Economic inequality appears across our neighborhoods, from Staten Island to Poughkeepsie. Because of financial requirements, many of our people cannot use traditional banks and lack access to basic banking tools. The disconnections impact the everyday lives of our people. • It's structural injustice— and it disproportionately impacts people of color. Economic and racial injustice are entangled. • Our credit union will open banking services to the underserved, while providing low-cost emergency loans and financial counseling. It will be independent and financially responsible. From Staten Island to Poughkeepsie, traditional banks exclude our people through financial requirements and unreasonable fees. The lack of access to basic banking tools disproportionately impacts people of color and New York's most vulnerable, from formerly incarcerated individuals to survivors of domestic violence.

To be like the Samaritan, we are taking action to address this injustice.

The credit union will be completely independent of the administrative structures of the Diocese, financially responsible, and accredited and insured by the National Credit Union Administration.

While the chartering process is almost complete, the very last step is to gather \$350,000 in pledge commitments from across the Diocese as required start-up capital.

Here's how you can help.

Could your congregation make a pledge to the credit union, perhaps from your thrift sale, holiday bazaar, or other fundraiser? Could you make an individual pledge?

To get things started, each task force member and every co-chair signed below has made a pledge, ranging from \$300 to \$15,000. Each of our parishes will make a pledge as well.

Right now, we need pledges and not contributions.

Our goal is to be able to announce at the November diocesan convention that we've completed the campaign. Our shared commitment can make a big difference for our neighbors.
