Minutes of the Annual Congregational Meeting

Holy Cross Lutheran Church

February 2, 2025

CALL TO ORDER – Council President David Winkler called the meeting to order at 11:30 a.m. Members completed signing in the attendance forms.

OPENING DEVOTION – Pastor Kraus opened the meeting by encouraging all present to join in reading the published liturgy from the ELCA. Pastor shared a prayer from St. Francis of Assisi.

ADOPTION OF AGENDA – Dave asked if any changes were needed to the agenda printed in the annual report. None were suggested. It was moved, seconded and all agreed to adopt the agenda.

VOTING FOR COUNCIL AND MEF CANDIDATES

Dave directed members to vote for no more than two candidates in each category. Ballots were distributed. Pat Goertzen and Kari Brangan collected and counted ballots.

STAFF, COUNCIL and TEAM and COMMITTEE CHAIRS

The following Council members are completing their terms: Kari Brangan and Kelly Caligiuri. Kelly is running for re-election. Dave thanked Kari for her valuable service for the past six years. Dave also thanked Pat Goertzen for his willingness to complete Dennis Hawley's term on the Mission Endowment Fund team.

Mary Bailey was thanked for her service as our new treasurer. Dave thanked Clarence Jentes for his long-term service as our financial secretary.

Dave thanked Penny Rudolph for serving as recording secretary for the past 7 years.

He expressed appreciation to all heads of teams and committees and to all Council members.

Dave also thanked Pastor, Carrie, Court, Dave, and Jack for all they do at Holy Cross each week.

MINUTES OF THE 2024 ANNUAL MEETING – Dave asked that all present review the minutes from the 2024 Annual Meeting (pages 5-10) and voice any corrections needed. No corrections were requested. Dave then asked for a motion to approve the minutes. The motion was made and seconded. All present approved the minutes as included in the annual report. No nays were expressed.

REPORT OF THE PASTOR/PASTORAL ACTS

Pastor referred us to his annual report which included his thoughts about the first few months he has shared with us at Holy Cross. Pastor believes we are an amazing congregation. Attendance at this annual meeting far surpasses the number of members who attend annual meetings in most churches.

He doesn't think we will have problems finding good pastoral candidates.

Our worship services are superb, largely owing to the musical direction provided by Dave and Jack.

Pastor commended our online presence, crediting Court's talents and her tenacity in sharing news of our services and engagement with the community.

The transition team did an excellent job crafting the Ministry Site Profile that the Bishop's office will review before making it available to pastoral candidates searching for a new church position. Lots of work went into this report. The transition team did an amazing job. The search will run well.

Pastor Kraus appreciates our care, love and support. This has been a good place for him to have returned following his retirement from full-time ministry in late March. He is happy to be among us and is thankful for us.

Dave echoed our appreciation for Pastor's service here.

HOLY CROSS ATTENDANCE TRENDS

Next, Dave referred to page 14 of the annual report to highlight several points on the attendance chart. Our online attendance is strong. More people worship in person during specific times of the year. (Please refer to Court Templeton's report on pages 18 to 20 for specific details.)

RECOMMENDED 2025 BUDGET – Referring to page 15 of the 2024 Annual Report, Treasurer Mary Bailey began discussion of the 2025 budget. She also referenced page 17 for the Balance Sheet Summary.

Mary commended Greg for his past many years of service and his tireless help with her training.

Mary thanked Clarence and Dave Ristau for their dedication too.

Mary mentioned today's Post Dispatch article about churches facing lots of building needs/expenses. At Holy Cross we have 10 air conditioners, 10 furnaces, two large roofs, and multiple bathrooms that all need attention. One trend is for churches to combine to lessen expenses related to building maintenance.

The total budget for 2025 has been cut by \$3,000. The budget may appear like we have cut staff salaries, but that is not the case. Staff members will receive pay increases. The lower figure shown for staff salaries reflects the fact that we currently employ an interim pastor who works $\frac{3}{4}$ time; we are not paying an established pastor a full-time salary.

This year we are increasing the property budget by \$6,000 because last year we exceeded our projected expenditures. This overrun occurred because of several large, unexpected repairs. Additionally, the cost of utilities and insurance have increased, factors that are out of our control. We are here to serve others so we sure hope not to spend all of our money on building repairs this year.

INCOME

Income for the new year is projected as \$324,275. When creating the budget, income is estimated from pledge cards and historical information.

We hope to receive additional income to avoid a potential net loss of \$21,000 this year.

The IRS still owes us money from the retention income credit we received since we didn't let go of employees during the Covid pandemic. We did have to pay Paychex \$6,300 to go after that money. We are still anticipating receiving an additional \$9,400.

\$8,000 for building use is built into the budget; it's lower than previous years because NewSong no longer uses our building and we have lost their donation.

GENERAL FUND (our checking account)

\$6,400 has been received already for the new building fund we have established and promoted.

Greg worked with the Finance Committee to create the 2025 budget (see page 16 of the report).

- Total budgeted expenses: \$363,044
- Total budgeted income: \$341,275
- Budget gap: \$ 21,769

Dave Winkler called for approval of the budget that Council has recommended. A motion was made, it was seconded and all present approved. No opposition was expressed.

REPORTS OF THE STAFF, COUNCIL, TEAMS, AND COMMITTEES

Dave asked for a motion to approve all committee reports and Pastor's report. It was moved, it was seconded, and all in attendance approved all reports as published.

Philip, on behalf of the vision team, invited all to join them. They are a mighty, but small group.

Dave said they were wonderful to help push us to be out in the community – to be who we are.

EXECUTIVE COMMITTEE REPORT

Dave Winkler highlighted his executive team report. The most notable item in the report was Pastor Janice's retirement. Dave thanked her for the years she gave us and he thanked Pastor Kraus for stepping in.

We made waves with the community. Scouts helped with some projects. One annual special initiative, Feed the Need, as well as charitable activities related to the Parkway schools are strong. He thanked everyone for the time we spent helping the community.

Dave also acknowledged the support he received from fellow executive team members, Bob and Kevin.

ROLL WAS TAKEN. Penny verified that the number of persons attending the meeting matched the number of ballots submitted (57 persons attended and 57 persons voted).

ELECTION OF CHURCH COUNCIL MEMBERS AND MISSION ENDOWMENT FUND TEAM

Nominating Committee Report:

Church Council Members (2 to be elected) Dave introduced the three candidates for Council whose bios are shown on pages 35-36: Courtney Andrews, Kelly Caligiuri, and Moira McCracken. We were instructed to vote for *a maximum of two candidates*.

Mission Endowment Fund Members (2 to be elected)

Dave introduced the three candidates for MEF whose bios are shown on page 36: Julie Aleshire, Jill Gehner, and Rocky Stone. We were instructed to vote for *a maximum of two candidates*.

Dave thanked all candidates for their willingness to run for office. He asked if there were any questions for any candidate; no questions were raised.

Dave requested nominations from the floor; no nominations were heard. Members were asked to vote. Ballots were counted and results were announced.

ANNOUNCEMENT OF THE ELECTION RESULTS

ELECTED MEMBERS

Mission Endowment Fund:

Julie Aleshire was elected. There was a tie between Jill Gehner and Rocky Stone. We were set to take a tie-breaking vote when Jill conceded to Rocky.

Julie Aleshire and Rocky Stone will each serve on the Mission Endowment Fund team for 3 years.

Council:

Courtney Andrews and Moira McCracken were elected and each will serve a 3-year term.

OLD BUSINESS

Youth continued to sell gift cards at Chili Bingo in 2024. Gift cards are still for sale. Interested members should contact Carrie in the office to purchase them.

NEW BUSINESS

Presentation of the Transition Team

Greg Miller: *BY THE NUMBERS*

Greg thanked us all for participating in the call process. He highlighted the transition team's progress:

7 transition team members

6 cottage meetings

66 folks participated

50 responses to the online survey

Last time it took 15 months to complete the process. The team hopes to shorten the process this time! Moira McCracken was part of the team last time so she will be very helpful in this new transition.

NEXT STEPS

The transition team met on Tuesday with the Call committee in the library to review the MSP in detail, ensuring consensus. The MSP is our resume of who we are – it will be used to guide our call process.

The call committee will take candidates through the points in the MSP and discuss their answers.

The transition team is done now. Once they learn the name of the call committee chairperson they will submit the MSP to the synod.

The call committee needs to feel comfortable conducting interviews because they could begin receiving candidate resumes soon.

Two rounds of three candidates on each round were received from the synod last time.

The transition team needs to educate call committee members on the compensation package.

Some factors that influence the pastor's salary are years as pastor and outside employment.

The salary used to be low but now starts at \$56,000 for someone just out of seminary. Salary scales up with more years of experience.

Thanks to the whole transition team, the MSP will now be available to print or read online.

PASTOR'S REPORT

Greetings in Christ Jesus!

With every bit of my being, I give thanks to God for Holy Cross Lutheran Church! Thank you for calling me as pastor and receiving me and my family into your congregation! These past few months have truly given us reason to celebrate and purpose to serve. With Jesus Christ as our Lord, the Holy Spirit working in our lives, and the greatness of God in all things, this congregation is moving into another pivotal season of life.

As we review our past year in ministry, we see that God is at work in this place. We can also observe that God's Holy Spirit is not done working in and through Holy Cross to reach into our community and connect (or reconnect) people to Christ in this place. The last year has been a season to slow down, reflect, worship, listen, and dream about God's work here. Heading into 2026, it is time to be inspired and inspirational – to repair and strengthen – to explore and discover – to learn and to adapt. We call upon God in prayer, open to what the Holy Spirit might put upon our hearts and our lips, and courageously step into the wild and unpredictable world that is yearning to be loved by God. *Amen!*

Transitional Ministry

- Pastor Gerhard Kraus served as interim pastor during the first part of 2025. After taking leave for health reasons, pulpit supply was provided by several area pastors. When arrangements were agreed upon, pastoral duties were assumed by Pastor BJ Arnold.
- Pastor Matthew Helfrich was called to serve as resident pastor and began serving in August. Installation occurred in regular worship service on August 24th with Bishop Candea and Pastor David Whetter.
- Pastor Kraus was called to his heavenly home on September 3, 2025. Arrangements for a memorial service are pending but will most likely take place in the spring of 2026.

Word and Sacrament – Worship

- Worship services have continued at designated times.
- We have continued streaming full-length worship services every week (with a couple technical hiccups).
- The order of service for both Traditional and Contemporary venues have continued as usual, with some changes to continuous communion distribution in the contemporary venue.
- Advent services were held in the smaller chapel following “Holden Evening Prayer” at 7 p.m. The choir was greatly appreciated for their participation.
- The larger baptismal font with flowing water was filled, moved forward, and turned on again. The smaller font was relocated to the rear entry for people to remember their baptism upon entering the worship space.
- The video connection was lost in the rear of the nave and resolved with the installation of a new cable.
- A new microphone and cable were installed in the rear as well to assist with better streaming sound.

Equipping the Saints – Education/Bible Study

- Tuesday Morning Bible Study has continued to review the Lutheran Handbook. This has led to many conversations about our faith and life as followers of Jesus.
- Men's Bible Study has been meeting twice a month on Monday evenings, studying the Book of Exodus.
- Children's Sunday School has been offered between services.

Pastoral Care

- When new pastors begin, it is common for congregations to get off to a slower start in requesting pastoral care. This has been my experience at Holy Cross. Please be encouraged to contact the pastor directly with any pastoral care hopes, prayer requests, and any other needs.
- People who are homebound or not able to attend worship services have been visited regularly with communion. Four individuals have been visited in the most recent months.

- Visits in hospitals/rehab facilities have occurred upon request.
- Other pastoral care meetings, phone calls, and conversations have occurred as people have shared need.

Community Outreach

- Relationships with area faith communities, congregations, and service organizations have been ongoing.
- Facility usage has continued; several groups gather here throughout the week. These groups have expressed their gratitude and shared with Holy Cross that it has been a blessing to be able to meet here.
- Financial assistance has been given to several folks in need.

Administrative Ministry

- Ongoing attention has been given to smoothing workflow and scheduling for events and facilities.
- Pastor moved into his office; he purged the shelves and updated the computer, monitors, and some furniture.

Wider Church

- Bishop Donna Simon was elected as bishop of the Central States Synod.
- The Fall Theological Conference was held at the Kansas City CSS headquarters. Here, Dr. Craig Nessen, Prof. Emeritus, Wartburg Seminary, presented how congregations can adapt to changes in context. This included a revived focus on training and empowering the baptized in ministry to have greater reach.

Continuing Education

- Pastor Matt completed Lutheran Transitional Ministry Association training for certification (6 Continuing Education Units) with financial assistance from CSS, LuTMA, Living Christ, and Holy Cross.

Fellowship

- Refreshments and fellowship gatherings moved upstairs when the elevator was in disrepair. During this time, it was noticed that the narthex was a preferred location to gather between services, so it continued.
- Additional tables and stools were added to the narthex, furniture was rearranged to create a more welcoming setting, and donuts were added to the selection of refreshments.

Vision and Direction – *Some questions to consider in prayer and with each other...*

- How well is Holy Cross organized (or disorganized) to currently follow Jesus into a new expression of what it is to be God's Church on Earth?
- Ask the question: What is it that makes the Ministry of Holy Cross essential in the lives of people in our community?
 - How has God uniquely placed us (both individually and as a group) at this time and place to fulfill the purposes of God?
- What would need to be different in the ministry of Holy Cross to make it more essential in the lives of people in our community?
 - If God were to tell us to start over, or shuffle the proverbial deck, how else might Holy Cross uncover and adopt God's mission in our world?
- What is missing that God really wants us to invest in as an expression of Jesus?
 - Are we ready to consider this? What might this mean for Holy Cross? Is this exciting to you? Why or why not?

As followers of Jesus, we go forth into the world, inviting everyone to come, see, and be part of what the Lord is doing.

It is also with great sadness that we learned that our Interim Pastor Gerhard Kraus had passed away. Pastor Kraus was well liked by the staff and members of our congregation and he will be greatly missed. We were able to use multiple supply pastors to continue providing Sunday services and Pastor Beverly (BJ) Arnold filled in as our bridge pastor until we were able to call Pastor Matt.

The Council held two retreats this year, using the framework of the Eastern Missouri Conference Retreat. The discussions covered forward-looking topics regarding how to grow the church, related to both membership and spirituality. VISION TEAM

Rather than starting by highlighting our 2025 accomplishments, it seems appropriate for the Vision Team to begin sharing our future focus as we enter 2026. It is an exciting time for us as we take advantage of having the fresh perspective of Pastor Matt Helfrich, who has been observing the strengths and areas for potential improvement for Holy Cross since he accepted our call. For example, we look to focus on who Holy Cross is and where we are going instead of making sure we have people signed up to fill roles. We see great opportunities for Holy Cross to be more accommodating to young families, and we want to lead the congregation's movement toward this.

The Vision Team will evaluate ways to improve our organizational structure to ensure our efforts support our vision. To make this a reality, the Vision Team will concentrate on developing strategies instead of running our various ministries (e.g., the Mitten Tree). We are looking for volunteers to help lead the ministries. We also look forward to collaborating more closely with the Holy Cross Council to enact our vision.

We would be remiss to not mention our 2025 successes, in collaboration with our Partnership teams:

Parkway Partners – In January, mittens and gloves donated to the 2024 Advent season Mitten Trees were distributed to Parkway elementary schools. The Adopt-a-Senior-Student drive was very successful, raising funds for 26 Parkway School District Seniors to cover their graduation fees. This allowed these students to “walk” at their graduation in May, and obtain diplomas and transcripts. Some late-arriving funds serve as seed funding for the 2026 drive, which has been kicked off. The Thanksgiving food drive to support the Parkway School District Food Pantry collected and distributed 248 stuffing mix boxes and 264 cornbread mix boxes, exceeding our goal (225 of each).

Lutheran Family and Children's Services – Holy Cross provided 25 children with Christmas presents during our Season of Sharing ministry.

Feed Our Neighbors Team – This partnership team organized two Feed My Starving Children “packs” this year, one in mid-April at Queeny Park and another in July at Lutheran Church of the Atonement in Florissant. The turnout by Holy Cross volunteers was tremendous for both events.

Welcome our Neighbors/ESL Team – This team met monthly with an English as Second Language (ESL) class that gathers at Holy Cross. They enjoyed a cup of coffee and sparkling conversation with class members who look to acclimate to life in the St. Louis region. Unfortunately, this successful ministry ended at the end of summer when the class organizers identified a requirement for Holy Cross volunteers to undergo a formal background check to participate.

Welcome Statement - A welcome statement was completed for Holy Cross to affirm that “All are Welcome” here and are invited to become members. This positive statement was affirmed by the organization, *Reconciled in Christ*, and was formally adopted by Holy Cross.

Our team is initiating a new “rotational chairperson” practice in which each member of the Vision Team will take a turn chairing our monthly meetings. It is with sincere gratitude that we thank Madde Hanson for chairing our team for the past four years.

We welcome and encourage your participation in building the Holy Cross Vision. Perhaps you want to collaborate with a Standing Team, a Partnership Team, or the Vision Team itself. Fresh ideas and helpful hands are always welcome as we bring God's acts of mercy to our community.

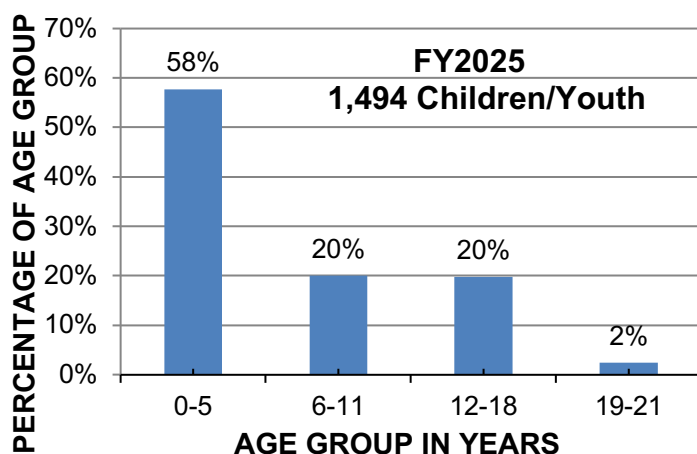

PROPERTY COMMITTEE

The mission of the Property Committee is to provide oversight, guidance and actual labor for the upkeep and maintenance of the church property. .

We ask anyone who uses the church to make sure they clean up after themselves, reset thermostats (to 65 degrees for unoccupied and as desired for occupied), turn out the lights, and lock the doors. We need to leave our building cleaner/better than we found it.

Some of the committee's accomplishments this year include:

- Implemented maintenance contracts and repairs for HVAC and elevator
- Repaired sanctuary roof/office wing roof leaks
- Back property work included mowing, erosion control and mosquito control -
- Cleaned carpets
- Several sections of concrete sidewalk were replaced at church entrance
- Back entrance concrete steps were repaired
- Repaired driveway potholes
- Continued replacement of interior lighting with efficient LED lights
- Signed contracts for lawn care and snow and ice removal
- Landscaping work included removing 11 trees ourselves (a great savings to the church!)
- Plumbing repairs
- Security system repair

We have looked at major property capital improvements needed over the next 10 years. This is a **LARGE** expense item. This year (2026) we plan to reseal the parking lot (about \$13K) and we will need a decision on whether to repair or replace the inoperative Old fellowship hall (OFH) air conditioner (estimated cost \$65,000).

Finally, I would like to thank all committee members for their dedication and hard work. Many of the above tasks were accomplished by property committee members. 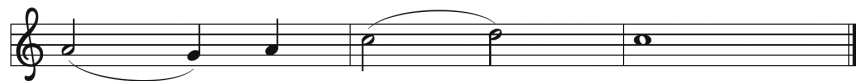
