



Quality Add-on Rates and Grants & Awards Structure Overview Fiscal Year 2017-2018

Keystone STARS resources are intended to support child care programs serving Pennsylvania's most vulnerable children as they develop and meet their quality goals. The RISING STARS SUPPORT GRANT, the MERIT AWARD, and EDUCATION AND RETENTION AWARD charts below indicate the maximum resources available, with approved expenses, to qualifying programs at varying Keystone STAR levels and are based on Full Time Equivalency (FTE). Family Child Care Home facilities eligibility could also be established by being enrolled in TIER 1 Child/Adult Care Food Program (CACFP) – administered through the United States Department of Agriculture (USDA).

Eligibility for grants and awards requires serving children participating in the Child Care Works program.

RISING STARS SUPPORT GRANTS

RISING STARS Support Grants will be awarded to selected providers in targeted areas. Providers selected may be eligible for enhanced Professional Development, materials, financial awards, or any other good or service identified by the sponsoring Regional Key. RISING STARS Support Grants are only valid within the Regional Key awarded and are non-transferable.
