

Keystone STARS Grant & Award Structure Overview FY 16 -17

Keystone STARS encourages and supports programs to develop and sustain higher levels of quality in order to strengthen outcomes for children and families and to improve school readiness. The RISING STARS SUPPORT GRANT, the MERIT AWARD, and EDUCATION AND RETENTION AWARD charts below indicate the maximum resources available, with approved expenses and submitted receipts, to qualifying programs at varying Keystone STAR levels, based on Full Time Equivalency (FTE). Family Child Care Home facilities eligibility could also be established by being enrolled in TIER 1 Child/Adult Care Food Program (CACFP) – administered through the United States Department of Agriculture (USDA).

Eligibility for grants and awards requires serving a subsidized population of no less than 10%.

RISING STARS SUPPORT GRANTS

RISING STARS Support Grants will be awarded to selected providers in targeted areas. Providers selected may be eligible for enhanced Professional Development, materials, financial awards, or any other good or service identified by the sponsoring Regional Key. RISING STARS Support Grants are only valid within the Regional Key awarded and are non-transferable.

Merit Awards at STARS 3 & 4 Group/Centers account for programs implementing authentic assessment of children.
