

What is the Child & Adult Care Food Program (CACFP)?

The CACFP is funded by the US Department of Agriculture through the PA Department of Education. Certified home-based Group and Family child care providers are able to participate under the sponsorship of Child Care Consultants, Inc. (CCC). The goal of the CACFP is to help children ages birth-12 years receive nutritious meals, while promoting healthy eating habits at an early age.



Joining the food program makes "cents."

You're partially reimbursed for serving healthy meals to children.

Reimbursements = extra income, even after taxes.

Your food costs count as a business expense, so you only pay taxes on the amount of reimbursement that is more than your food expense.

The quality, nutritious foods you serve meet federal guidelines for whole meals for children.
