Supervisor Solis:

We learned from Twitter last night that you were ordering the Chief Executive Officer to establish a mandatory vaccination policy by October 1, 2021. Though your order did not so specify, we are presuming that you were referring to COVID-19 vaccination.

ALADS and Sheriff Alex Villanueva have been engaged in the meet and confer process over the Sheriff's proposal that ALADS members either be vaccinated or receive negative weekly tests for COVID-19. Until last night, we had presumed that those negotiations were occurring with your knowledge and approval.

I am writing for two reasons. First, ALADS is asserting its rights to negotiate over both your decision and the effects of your decision to require that all employees be vaccinated. Please have your representatives get in touch with me to schedule negotiations sessions.

Second, ALADS is requesting answers to the following questions, all of which seek information relevant to the bargaining process. If you are able to furnish answers to these questions before the first negotiations session, it will be helpful:

- 1. Upon what provisions in the County's Charter or Code do you rely for the proposition that the Chair of the Board of Supervisors, acting alone, has the authority to impose a mandatory vaccination policy?
- 2. Your order does not contemplate religious, disability, and pregnancy exemptions from the mandatory vaccination program. Is it your intent that such exemptions exist?

- 4. Does your order supersede the authority of Sheriff Villanueva to negotiate with ALADS his proposed "vaccination or test" policy?
