1 IT IS ORDERED that an Order to Show Cause re: Preliminary Injunction issue in this
2 case enjoining and restraining Defendants County of Los Angeles, Los Angeles County Sheriff
3 Robert Luna and Office of Inspector General ("OIG")/ Max Huntsman, Inspector General for
4 the County of Los Angeles and their agents, employees and representatives, from engaging in
5 the following actions pending an adjudication of the merits of ALADS' Complaint/Petition as
6 follows:

7 1.) That Defendants are enjoined and restrained from compelling the attendance of
8 ALADS' represented Deputy Sheriffs ("Affected Deputies") in an impending "interview"
9 pursuant to the OIG's letter dated May 12, 2023 regarding the Inspector General's investigation
10 of law enforcement gangs and police misconduct at the Sheriff's Department; and

11 2.) That Defendants are enjoined and restrained from requiring the Affected Deputies to
12 produce at the aforesaid interviews, photographs of certain tattoos located on any part of their
13 bodies and/or be subjected to inspection of their bare legs for certain tattoos.

15 North Hill Street, Los Angeles California on 6/29 2023 at 9:30 why
16 Defendants have not done so;
