This facility plan is designed as a roadmap to guide the current board and future boards when making educational, financial, and facility improvement decisions.

# BASELINE FACILITY REPAIRS & UPGRADES:

- Health, Life Safety items & projects required by Illinois School Board of Education
- Safety and security enhancements
- ADA accessibility upgrades
- Domestic water pipe replacement to mitigate lead
- Electrical capacity upgrades
- HVAC upgrades with improved indoor air quality and temperature regulation across the District

#### **ADDITIONS:**

- Add 3 classrooms, multipurpose lunchroom (replace mobile classes)
- - multipurpose lunchroom
  - New classrooms for 5th grade
- Prioritization needed of KW/Gym storage, Resource Center, Cafeteria, and multi-purpose spaces across the District with the support of new architect, Perkins and Will.
- The Skokie School is planned to be decommissioned by 2023.

## **REDISTRICTING:**



Redistricting is necessary to balance enrollment at the three elementary schools. In the fall of 2019 the School Board approved new attendance boundaries after planning and input from demographer, District staff, parents, community leaders, the Village, and safety officials. New attendance went into effect at the start of the 2020-21 school year.

# ADDITIONAL EDUCATIONAL & ENVIRONMENTAL ASPIRATIONS

### **FACILITY DESIGN & RENOVATIONS:**

The Educational Master Facility Plan includes a tiered approach to facility design to support the District's vision for teaching and learning, improve equity and access to programming, and provide the maximum flexibility and function of facilities.

### SUSTAINABILITY:

As repairs, renovations, and updates occur over the lifetime of the EMFP, qualitative metrics pertaining to environmental and material sustainability should be applied as design criteria and codified as a part of the adopted EMFP. Notably, Student Centric Design, Sustainable Operations, and Energy Consumption are some of the high priority items among a range of important topics.
