# 2017 Parade Guidelines

- Prior to participating in the parade, entries must fill out the application and the liability waiver by no later than Friday, June 16th, 2017.
- The parade will start and finish at the Rochester High School parking lot located at 1 Zebra Lane, Rochester, Indiana. The route of the parade will travel East on 15th Street then North on Main and West on 8th . Participants will complete the entirety of the parade which ends where it began at the high school.
- All entries should arrive in the staging area, between 7:30 a.m. and 8:00 a.m. Entries that arrive after 8:00 a.m. will not be allowed to participate in the parade.
- The individual who completes the application and signs the waiver is thereby responsible for any and all participants within the entry group.
- The parade officials will be in charge and reserve the right to dismiss any entrant who does not abide by the parade rules. The parade officials also have the right to accept, reject, reclassify or remove any unit at their discretion.
- Entries that include minors must provide parents or other adult chaperone supervision.
- Parade participants on moving entries cannot ride on running boards, hoods, roofs or fenders.
- Any living creature on a moving parade entry must be secured (leash, crate, etc.).
- The handler of an animal must maintain full control of them at all times for the entirety of the parade. The handler must also have a plan in place for the immediate clean-up and disposal of animal waste.
- No firearms, fireworks or open flames will be permitted.
- Participants must complete the entire route, starting and finishing the parade at the designated areas.
- Through the route participants must remain continuing in a forward motion for the entirety of the event.
- Transportation to and from the staging/ line-up area and the pick-up location is the responsibility of the participants.
- Restrooms will be available at Rochester High School for the staging of the parade, however; the restroom is not a “dressing room”.
- When lining up for the parade in the Rochester High School parking lot, only vehicles that will be entrants in the parade will be allowed to enter. The excess vehicular traffic causes unneeded congestion.
- Drivers must stay with their vehicles and floats through the entirety of staging/ line-up and the parade. Floats must stay attached to their vehicles at all times.
- Parade entrants and floats must have a banner or signage that identifies the individual, organization or group participating (antique vehicles, tractors, etc. are encouraged, but not required to do so).
- Participants will have a designated number that they must place on the passenger (right) side of their vehicle/ float for identification purposes.
- If participants are throwing candy, they should be cautious in how they throw it out to the audience.
