JOB ANNOUNCEMENT: Senior Policy Manager

Position Summary:

The Senior Policy Manager will lead CCOF's California advocacy. This is a full-time position that reports to the Policy Director and is a California-based position.

Essential Responsibilities:

- Provide thought leadership on California policy strategy, including conducting policy analysis and research, setting statewide priorities, and developing and implementing legislative and administrative campaigns.
- Manage staff by both providing structure, mentorship, and day-to-day support as well as stewarding
 policy team culture and integration with CCOF programs.
- Build and sustain relationships with decision-makers, partners, and members to get things done.
- Manage policy campaigns and projects autonomously, including tracking timelines, data, budget, and information.

Specific Duties:

- Manage legislation on the California Healthy Soils Program
- Manage contract with state lobbyist, ensuring lobbyist is aligned with policy team priorities.
- Develop strategic communication content to support CCOF's policy initiatives.

Required Qualifications:

- Experience leading policy campaigns: Understands how to advance policies in coalition and has a track record of effecting change.
- Social justice & racial equity lens: Recognizes the role of race, gender, and other identities in shaping disparities and is committed to personal growth and advancing policies that address inequities.
- Highly organized, motivated, and detail-oriented with a strong sense of ownership and resilience:
 Plans ahead and finds alternative paths, when needed, to get to the finish line. Bounces back from setbacks and rejections. Holds a high bar even when things are hectic.

- Clear, precise, and compassionate communications skills: Speaks and writes clearly and is an active listener. Skillfully translates messages across various audiences and communication channels in an organized and thoughtful manner.
- Relationship-builder: Builds authentic relationships across lines of difference. Listens closely to understand needs or concerns and takes steps based on that input.

Desired Qualifications:

- Inclusive leadership and management with a coach and learning mentality: Helps others grow. Uses coaching, training, and feedback to develop others and support problem-solving. Sees mistakes as learning opportunities.
- Experience advancing policy in California: Familiarity with the intricacies of California policymaking and established relationships within the legislature and administration.

Physical and Travel Requirements:

- Frequent travel to Sacramento is expected
- Ability to work occasional nights and weekends
- Prolonged periods sitting at a desk and working on a computer
