RULES OF DECORUM Tribal Council Meetings via Zoom

- 1. All meetings will have introductions once the meeting is called to order and roll call has taken place. Proper introductions will identify those joining the meeting in-person and those joining via Zoom.
- 2. At applicable times during the meeting, questions and comments will be taken by the Tribal President/Vice President. When necessary, the Tribal President/Vice President may direct the question or comment to the appropriate person to respond.
- 3. You must state your name and the topic of your question or comment. Speak clearly, don't interrupt, and please be patient.
- 4. Every Tribal Member shall have the opportunity to speak once before any Tribal Member has the opportunity to speak twice.
- 5. Please mute yourself when not speaking. This helps to avoid background noise disrupting the meeting.
- 6. Audio/visual/live stream recording of the meetings is prohibited and any Tribal Member found doing so will be immediately removed from the meeting they are joining in on and may be barred from joining in on any further Tribal Council Meeting held via Zoom.
- 7. Tribal Members asking questions or offering comments are asked to do so in a respectful manner. Anyone being disrespectful or intentionally disregarding the Rules of Decorum will be asked to refrain from continuing to do so and anyone that refuses to do so will be removed from the meeting they are joining in on and may be barred from joining in on any further Tribal Council Meeting held via Zoom.
