Several retirees enrolled in Medicare (65 years and older) have reported experiencing problems with their healthcare provider, including:

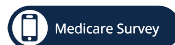
- Getting a doctor assigned

CANCER SCREENING HOSTED BY MOUNTAIN VIEW FIRE FIGHTERS, LOCAL 1965

Mountain View Fire Fighters, Local 1965 is hosting a cancer screening event on March 20-24, from 9 AM to 3 PM at Mountain View Fire Station 1, 251 S. Shoreline Blvd., Mountain View, CA 94041. The test is provided by Galleri, a new cancer screening company that has partnered with the San Francisco Fire Fighters Cancer Prevention Foundation. The test is one of the gold standards for early cancer screening and has successfully caught cancer for nine active and retired members of San Francisco Fire Fighters, Local 798.

Most proposed updates modernize our bylaws for consistency with current laws and practices, such as the use of video meetings. In addition, we are proposing to relieve non-sworn survivors of the need to pay annual Association dues to allow them to stay connected to the Association without any financial burden.

The most significant change we our proposing seeks to attract and retain members to serve on the Board of Directors by offering a nominal monthly stipend – \$200 for the five executive board members and \$100 for board directors. This equates to a monthly cost of \$1,500.

We are hopeful these stipends will not only honor the significant personal time board members dedicate to our Association, but will also incentivize a new generation of leaders to step forward to guide our Association into the future.

MEDICAL PREMIUMS DEDUCTION

IRS Publication 721 for 2022 by Ken Jacksteit

I am not a tax attorney nor am I a qualified tax preparer. This information is for you to take to your tax preparer to see if you qualify for this deduction.

Distributions Used to Pay Insurance Premiums for Public Safety Officers

If you are an eligible retired public safety officer (law enforcement officer, firefighter, chaplain, or member of a rescue squad or ambulance crew), you can elect to exclude from income distributions made from an eligible retirement plan that are used to pay the premiums for accident or health insurance or long-term care insurance. The premiums can be for coverage for you, your spouse, or dependents. The distribution must be made directly from the plan to the insurance provider. You can exclude from income the smaller of the amount of the insurance premiums or \$3,000. You can only make this election for amounts that would otherwise be included in your income. The amount excluded from your income can't be used to claim a medical expense deduction.

For this purpose, an eligible retirement plan is a governmental plan that is:

- A qualified trust,
- A section 403(a) plan,
- A section 403(b) annuity, or • A section 457(b) plan.

The CSRS and FERS are considered eligible retirement plans.

How to report. *If you make this election, reduce the otherwise taxable amount of your annuity by the amount excluded. The taxable annuity shown on Form CSA 1099-R does not reflect this exclusion. Report your total distributions on Form 1040, 1040-SR, or 1040-NR, line 5a. Report the taxable amount on Form 1040, 1040-SR, or 1040-NR, line 5b. Enter "PSO" next to the appropriate line on which you report the taxable amount.*

If you are retired on disability and reporting your disability pension on line 1a of Form 1040, 1040-SR, or 1040-NR, include only the taxable amount on that line and enter "PSO" and the amount excluded on the dotted line next to the applicable line.

The three takeaways from this are:

1. You must be an eligible retired public safety officer.
2. The insurance premiums must be deducted from your paycheck and paid directly to the insurance provider.
3. Any insurance premiums you pay directly, i.e., from your checking account or credit card, including Medicare, does not qualify.

If you qualify for this deduction, you will need the year-end total of your insurance premiums for 2022. This amount will not be on your 10-99. Look on your December paycheck for the YTD total of your qualified insurance premiums.

If you have been unaware of this deduction and have any questions, please take those questions to your tax preparer.
