What is the National Trails System?

The National Trails System Act of 1968 established a national system of trails in the United States to promote the preservation of, public access to, and enjoyment of outdoor areas and historic resources, including four trail categories:



- **National Scenic Trails**
- **National Historic Trails**
- **National Recreation Trails**
- **Connecting/Side Trails**

National Scenic Trails





WHAT IS THE CORPS?

A BODY OF PEOPLE ENGAGED IN A PARTICULAR ACTIVITY

- The Civilian Conservation Corps was established in 1933 as an effort to employ young men during the Great Depression.
- Today, AmeriCorps is an independent government agency for volunteerism.
 - **Workers are paid living stipends and often receive education awards upon completion of their work program.*
 - **Work consist of urban and rural projects.*

WHAT IS THE IMPORTANCE OF BCH CHAPTERS ENGAGING WITH THEIR LOCAL CORPS?

- The more youth we can involve with BCH, the longer BCH chapters can thrive for years to come.

**Youth provide diversity in input of local problems, projects and events. They also have broader communications.*
