a. Thank members of the Public Lands Caucus for defeating a proposal in the House of Representatives to sell over 450,000 acres of public land as part of the current budget bill, and

b. Encourage US senators to oppose a broader plan—the sale of up to 3.3 million acres—of public land in 11 western states, as proposed by Chairman Mike Lee of the Senate Energy & Natural Resources Committee.

BCHA issued action alerts to membership via its monthly email updates and to national directors (on June 11 and on June 19) asking them coordinate an action plan for congressional outreach within their state in order to push back on Senator Lee's proposal. Randy also worked to include BCHA in two sign-on letters from national and regional recreation and conservation organizations calling for action from Senate leadership and the Western Governors Association to oppose large-scale federal land sales.

Equestrian Legacy Radio – Randy used BCHA's monthly opportunity via the airing of *Saddle Up America* to educate host Gary Holt's audience regarding the high stakes associated with Senator Lee's proposal for wide-scale federal land transfer to the states. <u>Partnerships:</u> Mark and Mack have reached out to Back Country Hunters & Anglers but no response from the yet. There have been some issues with them using our BCHA (Copyrighted).

BLM is accepting our Light on the Land and putting it on their website with a link. BLM is also working on a project with John Chepulis. Identifying trails locally, through each state; you will contact your local person, and they will state how they want to identify the trails. *Saw Committee*: We are pushing forward with the saw training in the Mark Twain Forest in Missouri, this training will take place in September. There is only one rec person, and the Chair made contact with a region 9 person, and they said yes to our training. Looking to help region 8 and 9. The prices are reasonable.

Forest Service: Things are going to change quickly, they doubted there will be any regional saw program managers going forward. If the regions disappear, we go to the forests or the districts separately.

For BCHA to have their own saw program we would have to go from a volunteer to a cooperator, and then we are into liability insurance.
