

**Jonathan Kusowski – Stormwater for Auto Recyclers** – Stormwater is one of the main pathways salvage yards can contaminate the environment. Routine drips and spills are expected and can be managed, but what happens when there is a large spill? This session will review the 9.11.24 fire that occurred at the Morrison's Auto - Edgerton Facility and the spill prevention measures taken to get a clean bill of health from the DNR. **Note:** This session will count for my CCP member's annual meeting.

**Sue Schauls – Safety for Auto Recyclers** - Safety is often thought of as compliance with OSHA rules, but safety compliance is also an assurance that your facility is safe for employees and customers as well as insulated from enforcement action or fines. Using the certification program safety standards and resources makes it easy to achieve compliance and peace of mind. This session will review the required safety rules for auto recyclers.
