Vision

- Understand the historical perspective, purposes, and legislation related to dual enrollment, including goals of equitable outcomes and cultural proficiency.
- Understand the various models of dual enrollment, including different visions, purposes, facts and action, outcomes (including AP vs. dual enrollment).
- Identify opportunities for operationalizing the dual enrollment vision throughout the partnership, including aligning policies, processes, and procedures towards coherence.

Culture

- Articulate the “why” for leading dual enrollment work and the “why” of your organization and the partner organization.
- Understand the do’s and don’ts for high school teachers and college professors teaching in dual enrollment programs.
- Articulate the different benefits of a dual enrollment experience for diverse students while holding high expectations for all.

Pathways

- Identify and understand the following: Intent of CCAP, pathways models, Guided Pathway Pillars, vision for success.
- Identify multiple avenues to develop appropriate methods of pathway development that best meet the needs of their students, K-12, college, and partners.

Progress Monitoring

- Understand key components of K-12 accountability system, including the College and Career Index as it relates to DE.
- Select appropriate metrics tied to Dual Enrollment program vision and goals and plan for progress monitoring and program evaluation within the partnership.
- Understand FERPA and data sharing between organizations.

Student Supports

- Advocate for and create systems of equitable practices supporting all dual enrollment students.
- Identify multiple avenues to provide timely and appropriate interventions to best meet the needs of their students. (individually and as a team)

Counseling Services

- Understand the various roles of counselors (K12 & college) relative to dual enrollment.
- Understand the components of intrusive counseling
- Identify appropriate protocols to access information relative to FERPA, including faculty communication.
- Understand the similarities and differences of supports for students with disabilities.
- Understand various models of high school credit for college classes and the possible student effects.

Admissions & Records, Staffing

- Understand Admissions & Records needs associated with dual enrollment students, and how procedures might differ from general community college students and/or dual enrolled students not involved in a structured program, such as a CCAP program or a middle/early college program.
- Investigate the role K-12 and college staff perform in the overall admissions process of dual enrollment students.
- Understand staffing logistics including K-12 credentialing, minimum qualifications, and implications for the employer of record.

Budgeting

- Understand the various funding models (K12 & college) relative to dual enrollment.
- Understand the components of a Dual Enrollment budget
- Understand various models for funding textbooks.
- Identify various grant opportunities.

Stakeholder Engagement & Messaging

- Identify the key stakeholders involved in a Dual Enrollment partnership and which to engage at various stages and purposes.
- Understand best practices in working with stakeholders, including partner organizations, board of trustees, advisory groups, labor partners, faculty, parents, and students.
- Craft messaging specific to each audience.
