

TRUMP ADMINISTRATION'S PAUSE OF FEDERAL FINANCIAL ASSISTANCE: HEALTH CARE IMPACTS

EXECUTIVE SUMMARY

On Jan. 28, the White House Office of Management and Budget (OMB) [directed](#) federal agencies to submit details on funding programs with planned activities through March 15, using an attached [spreadsheet](#) due by Feb. 7. This follows an OMB [memo](#) temporarily halting federal fund disbursement to ensure compliance with executive orders, raising confusion and concern, particularly in the health care sector. The freeze could affect billions of dollars in grants supporting health centers, hospitals, universities, and research institutions, with the Department of Health and Human Services (HHS) managing nearly 38,000 active grants totaling \$714.5 billion in authorized spending for fiscal year 2025.

While Medicare, Social Security, and certain direct-to-individual grants are exempt, OMB's spreadsheet lists 433 HHS programs impacted by the freeze, including Medicaid. However, uncertainty persists about the implications for Medicaid, as over a dozen states have reported difficulties accessing payment systems for providers since the guidance was issued. The administration has since clarified that Medicaid and the Supplemental Nutrition Assistance Program (SNAP) were not intended to be affected, but vague wording in the directive has left health care providers and stakeholders concerned about potential funding disruptions.

This special report provides a comprehensive breakdown of which health care programs are impacted by this latest action, organized by agency.
