Presenting Company Selection Criteria

Please note: Presenting Companies need not be actively looking for fundraising in order to present. The following are guidelines, and all submitted company applications are up for subjective override by the Industry Advisory Board, at their discretion

Stream Focus:

- Information & Communication Technologies
- Health Technology & Life Sciences
- Agricultural Technologies
- Sustainable & Ocean Technologies

Core Criteria for Growth Stage Presenting Companies:

- Seeking a B round or higher
- Can be a current portfolio company that is meeting its milestones
- Promising technology and business model
- Watched with interest by the venture community
- Ideally have \$1M - \$5M in revenue

Core Criteria for Early Stage Presenting Companies:

- Angel Backed
- Ready for an A round
- Promising technology and business model

Selection Process



- Industry Advisory Board members typically refer the AVF project management team to the CEO of a company of interest
- The AVF project team then briefs the company of interest on the opportunity to present and provides them with an [application form](#)
- The company provides a verbal commitment of its interest to present and submits a completed application form, which must be submitted before the company can be selected
- The Industry Advisory Board grants final approval of all company selections after applications formally close on **August 20, 2021**
- The selected presenting companies will then receive a formal offer letter from the AVF project team and have 48 hours to accept & register

Registration Cost

- Presenter will register online for free using their promo code provided upon acceptance
- Once a company has received their formal offer letter, online registration must be completed within 48 hrs in order to confirm acceptance

Logistics

- The Atlantic Venture Forum is a SHOWCASE opportunity for exceptional technology companies - presenting companies need not be actively fundraising in order to present
- Detailed program, timings and logistical details will be forwarded upon company selection
- Company profiles to be submitted to the AVF project team following acceptance from the Industry Advisory Board.
- All companies will have 5 minutes to present
- PowerPoint slides must be submitted by **October 18, 2021**
- Presenting companies have the opportunity to be featured on the exhibitor page of the event app.
