Note: Presenting Companies need not be actively looking for fundraising in order to present. The following are guidelines, and all submitted company applications are competitively selected by the Project Management team.

Core Evaluation

- Minimum of \$250K in Angel/Seed Investment
- Looking for an A round or socializing a B round
- Can be a current portfolio company that is meeting their milestones
- Promising technology or business model
- Watched with interest by the venture community

Selection Process

- Company selections are made on an ongoing basis.
- Advisory Board members typically refer the project team to the CEO of a company of interest.
- The AGRI Tech Venture Forum project team then briefs the company of interest on the opportunity to present at the Forum and provides them with an application form.
- The company provides a verbal commitment of its interest to present and submits a completed application form, which must be submitted before the company can formally be selected.
- Presenting companies will then receive a formal offer letter from the AGRI Tech Venture Forum team.

Registration Costs

- \$1,095.00 CDN (Presenter)
- \$695.00 CDN (Each Additional Delegate)
- Once a company has received their formal offer letter, online registration and payment must be completed within one week in order to confirm acceptance.

Logistics

- The AGRI Tech Venture Forum is a showcase opportunity for exceptional ag tech companies - presenting companies need not to be actively fundraising in order to present.
- Detailed program, timings, and logistical details will be forwarded upon company selection.
- Company presentations are to be a maximum of 10 minutes.
- PowerPoint slides must be submitted in advance.
- Presenting Companies have the opportunity to set up an exhibitor booth at the Forum.
