



## Information Memo: Trusted Learning Environment

### Background

All school systems depend on data to support teaching and learning ([Infographic on Student Data](#)) as well as the daily operations of the school system. With national and local news coverage of data breaches on a regular basis, there is much concern for student data privacy and protection. All school systems take measures through board policy and practices to protect student data, but having a consistent plan and making that plan transparent to all stakeholders has been a missing piece.

### CoSN

[CoSN](#) (the Consortium for School Networking) is an international organization that supports school system technology leaders. CoSN provides thought leadership and resources to help leaders support learning in the 21st Century and beyond. Many of those resources include best practices and advocacy tools.

One of CoSN's initiatives is the Trusted Learning Environment (TLE) Seal. This resource identifies 25 data security and privacy best practices in five focus areas: Leadership, Business, Data Security, Classroom and Professional Development. The goal of this initiative is to shift the conversation around student data privacy, which can be reactive and fearful, to one of "trust." By participating in the TLE program, District 36 is demonstrating our commitment to high compliance standards and to ongoing review and revision of privacy practices as they evolve. Through the process of earning, and maintaining, the TLE seal, Winnetka Public Schools will have improved its capacity for handling sensitive and private information.

### 5 Focus Areas from CoSN's TLE

1. *Leadership*: manage and collaborate with stakeholders regarding the use and governance of student data to inform instruction
2. *Classroom*: implement educational procedures and processes to ensure transparency while advancing curricular goals

3. *Data Security*: perform regular audits of data privacy and security practices and publicly detail these measures
4. *Business*: establish acquisition vetting processes and contracts that, at minimum, address applicable compliance laws while supporting innovation
5. *Professional Development*: require school staff to conduct privacy and security training, and offer the instruction to all stakeholders

In addition to CoSN, there were three key partners in the development of the Trusted Learning Environment Seal:

- AASA, the School Superintendents Association
- ASBO, the Association of School Business Officials International
- ASCD, the Association of Supervision and Curriculum Development

### **Building a Team**

There is power in numbers and to ensure success with completion of the Trusted Learning Environment application. Maureen Miller, Director of Technology, has developed and facilitated a cohort of educators that has grown from two to twenty-one (anticipating over fifty cohort members by July of 2019.) Each of the cohort members is working with their own district's leadership team to review the five focus areas and gather evidence. By sharing evidence from various school districts, the cohort will have a variety of resources available to match the needs of their own stakeholders. The District 36 team will review resources and align practices to prepare us for the TLE Seal.

### **Next Steps:**

- Continue to extend network of TLE Cohort member districts (intent is to include all Illinois CoSN member districts) to increase the shared resource library
- Create Data Security and Privacy Task Force for Winnetka Public Schools made up of representative stakeholders with experience from each of the 5 focus areas
- Gather existing evidence of compliance to for each of the 5 focus areas (25 practices)- D36 [roadmap](#) created
- Create, communicate and share resources to our stakeholders as they are developed
- Submit "trial" application for TLE in August of 2019 with the expectation of the need to improve based on specific feedback that will be provided in the review process.
