












MedShare Donation Guidelines

Please do NOT put the following items in the MedShare barrel:

	NO Expired Items, or with less than 12 months before expiration (18 months + preferred)		
	NO Liquids		NO Pharmaceuticals
	NO Used or Damaged Disposable Products		NO Batteries
	NO Trash		NO Hazardous Materials
	NO Items recalled by the FDA, any safety organization, or any other U.S. government agency.
