## Terms and Conditions



---

Please read carefully the following Terms & Conditions. If you register or bid on items within this website, you accept these conditions.

1. All registration information the bidder provides to MPT shall be current, complete, and accurate. You may not use a false e-mail address, impersonate any person or entity, or otherwise mislead as to the origin of a card or other content. You will be suspended or banned if you provide false information when registering. Must be 18 years or older to participate in auctions.
2. When visiting MPT Auction websites, you are communicating with us electronically and consent to receive electronic communications from MPT.
3. In order to register to bid, you are required to enter your payment information. This information will not be used unless you are the winning bidder of an auction item.
4. As a bidder, you are responsible for any and all bids placed under your bidder number and password. If you feel your bidder information has been compromised, notify the MPT auction team immediately.
5. **Bidder Bucks:** Register to bid in the 2025 MPT Online Auction before it goes live (anytime before midnight on Wednesday, April 30, 2025) for a chance to win up to \$100 in Bidder Bucks. Five early registrants will be randomly selected to receive this benefit. If you are the winning bidder on an item or items and are awarded Bidder Bucks, up to \$100 will be deducted from your total winning bids, reducing your final charge accordingly. If you are selected for bidder bucks but do not win an item in the auction, your bidder bucks are null and void. If the total amount of your winning items is less than \$100, your bidder bucks will be only up to the amount owed. Bidder bucks have no cash value.
6. Once you place a bid, and if you win, you will be obligated to buy the item at the said price you indicated as your bid. When the auction closes, full payment is automatically charged to the credit card placed on file at registration. You will automatically receive a receipt from ClickBid outlining the charges for your winning items.
7. Auction winners will be contacted via email within 48 hours of the auction closing to arrange for pick up or delivery of items. If you do not receive this email, check your spam folder. If not there, please contact the MPT Special Events & Community Engagement team at [auction@mpt.org](mailto:auction@mpt.org) or call the auction coordinator at 410-581-4137.
8. The MPT Foundation will make all reasonable efforts to deliver or schedule pick-up of the winning items as described in these Terms & Conditions to the winners within two weeks of the auction closing. Time-sensitive items will be prioritized.
9. Items are not eligible for refunds, exchanges, or returns. MPT is not responsible for replacing lost, stolen, or damaged items.
