## MEETING NOTES:

1. Opening Prayer - Amy Schrimpf
2. Budget Update - Nicole Chapman

- The current bank balance is $\$ 122,978.18$
- Income
- Monthly income was $\mathbf{\$ 6 , 2 1 9}$
- The largest sources of income were Kroger Rewards (210 households are registered), Magazine Sales, Junior High Dance and Spirit Store.
- A rep stated that she can see her St. Charles designation on Click List.
- Reps were asked to remind parents to designate St. Charles as their Kroger Reward beneficiary.
- This can also be promoted in the Charger Chatter.
- Expense
- Expenses for November totaled $\$ 6,647$.
- Project fund purchases such as Faith Family t-shirts, STEM kits and new walkie talkies all contributed to expenses.
- Directories cost $\$ 575$.
- Field trips also registered expenses this month.
- Potential expenditures
- Mr. Bogle talked to the Kid Whisperer about doing a program for parents.
- The cost would be $\$ 1,000$.
- The teacher rep is going to talk to Mr. Bogle to find out what all the program would entail.
- A few attendees thought the price seemed high.
- Another attendee stated that educational consults like this typically can range from \$2,000-\$4,000.
- This program will be revisited in January.

3. New Business - Amy Schrimpf

- There is typically a staff luncheon during Catholic Schools Week.
- The PTO President would like to see PTO take care of providing food and supplies for the luncheon.
- A bring it list will go out in early January.
- Reps were asked to contact Amy with any ideas for the luncheon theme.
- A parent volunteered to organize and take up a collection for Christmas gifts for the specials teachers.
- It was suggested during the EC meeting that there isn't enough time to coordinate these this year.
- A rep asked if the parent would be willing to do the collection for end of year gifts instead.
- It was agreed that this was a good idea.
- Amy will reach out to the parent to communicate this suggestion.
- It was asked whom the collection should be divided among...should the nurse, counselors and front office staff be included?
- A rep said that she felt the front office staff would be more likely to receive gifts around the holidays.
- Another rep stated that she always gives the nurse a gift because the nurse takes care of the rep's daughter and her allergies.
- The general consensus seemed to be that specials teachers and Mr. Bogle should be the recipients.
- Parents can include in their notes a reminder encouraging parents to remember specials teachers and other staff around the holidays.
- Future PTO meetings will be held on January 16th, February 20th, April 10th and May 8th.
- The Executive Committee decided to continue holding the EC meeting in the hour before the full PTO meeting.

4. Old Business - Amy Schrimpf

- People have been better about not using handicapped parking spots at pickup.
- A rep commented that Kettering PD has been around school more frequently.
- It was asked if anyone heard back from parents interested in filling the role of 2nd Vice President.
- So far there has not been any interest.
- This can be advertised in the Chatter.

5. Upcoming Events

- The skating party at Skate World is scheduled for January 24th.
- Game night at St. Charles will take place on January 31st.
- Fish ' $n$ Chips is scheduled for March 15th.
- Michael Taylor would like a co-lead for alcohol as he only has one more year at St. Charles after this current year.
- The PTO President said that she volunteered her husband to fill this role.
- Another rep asked if a co-lead was still needed for the audio/visual component.
- There is still a need.
- The rep stated that her husband would be willing to help Matt Bourquin with this.
- PTO will connect these two parents.
- One of the silent auction leads asked the group if they would be interested in an auction item where a priest would say Christmas Day mass at the person's home.
- One rep said she had given this more thought and believed it would be a more popular item if one had many out of town or older guests staying with them.
- The overall consensus was that this was not something people had much interest in.
- The group was also asked about their interest in 6 Cincinnati Bell suite tickets for the final UD men's conference basketball game.
- A number of attendees said that the tickets might be appealing to businesses wanting to entertain clients.
- The tickets, which include food and beer, are valued at over $\$ 1,000$.
- These will be auctioned off sometime in January and/or February, likely in the front lobby of school.
- A parent approached an officer about possibly having a Zumbathon fundraiser for St. Charles.
- St. Charles parish and school are trying to limit the number of fundraisers that take place during the year.
- Instead of a fundraiser, the idea was floated to have a Zumba exercise day for parents and kids.
- Most reps considered this to be a good idea.
- The parent who came up with the idea will be contacted to find out cost and scheduling.


## 6. Additional Topics

- Mr. Bogle spent $\$ 760$ to upgrade the walkie talkies used by Safety Patrol.
- Currently, Mr. Samudio and Mr. Bogle are awaiting a new quote for updating the sound system in the PAC.
- The current PTO fee of $\$ 100$ per family may be changed to a School fee.
- This possible change would allow Mr. Bogle and teachers to make decisions about field trips and other school related items.
- PTO could focus on fundraising and community building events.
- A meeting will take place in January to discuss this further.
- A rep asked what would happen to some of those "wishy washy" items like the end of year party fund.
- The President indicated that the PTO Secretary would like to see the \$5/student end of year party money remain.
- Another rep asked how 7th and 8th grade events are paid for.
- These are covered under Field Trips.
- Essentially, all things remain the same, but the fee would get a new name, and PTO would have less responsibility when it comes to school matters.
- Mrs. Brown informed PTO that she has bought more STEM books with the money from Fish 'n Chips 2018.
- She has now spent around $\$ 1,000$, and said that a number of books have been checked out.
- Mrs. Brown also wanted to remind PTO that the used book fair will be coming in later January.
- The 4th grade made a Wish Tree that is currently on display on the door to the library.
- The President said that on another positive note, she heard from one of her doctors that a number of kids have transferred to St . Charles because it is such a good school.
