Here’s the latest edition of ***People on the Move***.

Pamela McPeters, a veteran around the Capitol for the past 20 years, has joined the lobby team at the ***Texas Classroom Teachers Association***. She previously held the position of Vice President of Public Affairs at ***TexProtects*** and has also worked for members and committees of the ***Texas House of Representatives*** and ***Senate***, including the ***House Committee on Public Education***. “With her extensive experience and knowledge of the process, she will enhance our lobby team as we continue to advocate on behalf of Texas teachers,” said TCTA Executive Director **Jeri Stone**.

Joel Speight joined the ***Texas Facilities Commission*** as chief operating officer.
