Booster Shots

COVID-19 Vaccine booster shots are available for the following Pfizer-BioNTech vaccine recipients who completed their initial series at least 6 months ago and are:

- 65 years and older
- Age 18+ who live in <u>long-term care settings</u>
- Age 18+ who have <u>underlying medical conditions</u>
- Age 18+ who work in <u>high-risk settings</u>
- Age 18+ who live in high-risk settings

Pediatric Vaccination:

Where Can I Get a Booster?

The federal government's <u>Vaccines.gov</u> website lets you search for vaccine and booster providers by zip code, with links to appointments, and many sites permit walk-ins. Many county health clinics, doctor's offices and pharmacies, including large chains like CVS, Walgreens and Walmart, are taking vaccine appointments, and lots of them offer walk-in vaccinations.

Check with Fairview Hospital in Great Barrington and BMC in Pittsfield for booster shot appointments.

Masking Policy

BHS is requiring all patients and visitors entering a BHS facility to wear a new medical-grade mask issued by BHS. This mask order has been mandated by the Massachusetts Department of Public Health.

By distributing new masks, we can be confident that the masks of all patients and visitors have not degraded or been soiled or compromised. Masks will be issued at the entries to all inpatient and outpatient facilities and will also be available at the front desks of our BHS practices.

Visitation Policy

Visitation will now be limited to one healthy visitor per patient at both BMC and Fairview Hospitals in adult medical/surgical units and in pediatrics.

No changes are being made to visiting hours, which continue to run from 12:00 Noon to 8:00 PM daily in the adult medical surgical units and from 2:00 PM to 8:00 PM in the Critical Care and Progressive Care units.
