National Fund for Sacred Places

LOI due March 2023

Can apply for \$50,000-\$100,000 with 1:1 match by donors or \$100,001-\$250,000 with 2:1 match by donors.

Needs: Originally built as a place of worship, owned by active community of faith, 3+ year old congregation, religious congregation or close nonprofit affiliate, property must possess historical, cultural, or architectural value and/or be listed or eligible for National Register of Historic places, occupied by congregation that is community minded and serves nonmembers, urgent repair needs for buildings, must provide a need for this project that is beyond the normal donor base, funds acquired before application process has been completed do not count towards match of grant.

Dr. Scholl Foundation

Application opens Oct. 1; LOI due by March 1st, 2023

Can apply for \$5,000 to \$25,000

Needs: IRS 501(c)(3) determination letter and 3 years of financial activity.

Walmart Local Community Grants

Application due Dec. 31st, 2022

Grants from \$250 to max of \$5000

Needs: must operate on local level, submit up to 25 applications and receive up to 25 grants in 2022 grant cycle, must be CyberGrant FrontDoor verified before applying, church or faith-based organization with a proposed project that benefits the community at large.

The Max and Victoria Dreyfus Foundation

Application due for Spring Round between May 11th and Nov 10th; for Fall Round between Nov 11th and May 10th.

Grants from \$1,000 to \$20,000

Needs: Application requires organization and contact information, answers to questions related to your organization's non-profit status, answers to questions related to past

awards/requests, a summary of your organization's purpose and programs, a summary of how potential funding would be utilized, a letter of request, your most recent 990 (if applicable), an itemized organization budget, an itemized program budget (for organizations applying for program support), and a copy of your organization's IRS letter stating your Section 501(c)(3) tax-exempt/ not a private foundation status. Cannot submit during consecutive grant cycles, can reapply the next cycle.

The Lawrence Foundation

Applications with 2 grant cycles due April 30th and October 31st

Grants from \$5,000-\$10,000 with option for more with knowledge of organization over time

Needs: charitable 501(c)(3) organizations with interest in environment, human services; portions of grant can be used for reasonable indirect costs, likely to be denied if church.

Disciples Women Endowment Fund

Applications due Oct 15th and March 15th

Grants max at \$5000

Needs: Only DOC members are eligible, grant to fund work that helps edify women, one time grant, must wait 4 cycles to reapply if grant is received, program impact.

Country Club Christian Church Grants and Special Offerings

Cycle begins July 1st; Applications due Sept 16th

Sustaining Grants: \$2,500-\$10,000; Special Grants: \$500-\$5,000 and may resubmit application every 12 months

Needs: organizations empowering children to learn, eliminate hunger, and move people from poverty to self-sustaining; communities that can be built upon, Christian in nature, associated with DOC ministries, or current or potential outreach and mission partnerships in Northeast KC area. The types of support granted through the Grants & Special Offerings Program include general/operating funding, program development, curriculum development, continuing support, equipment, seed money, annual funding, emergency funds, matching grants and capital campaign projects, conferences and seminars.

Most applications ask \$5,000 for tangible items, one-time capital expenses, new programs, or supplies for existing programs.

Needs: 501(c)(3) with federal tax ID number, operate in greater KC area, budget not exceeding \$5 million.

Needs: funds religious organizations, or construction projects and renovation projects.

Funds must also be raised by other donors and submitted at time of application, names of donors included in application, 40% of total cost raised by application submission.

Mabee will provide up to 20% of total costs for projects. Must be located in Kansas

Needs: Low income communities and lack adequate parks or other outdoor recreation space, to increase access to nature's benefits, must be stated led agency to apply, but can use state to help apply.
