WHAT IS “MINISTERIAL STANDING” AND WHAT IS THE AUTHORITATIVE DOCUMENT THAT INFORMS REGIONAL POLICIES FOR RENEWAL AND RETENTION OF STANDING?

Theological Foundations and Policies and Criteria for the Ordering of the Ministry of the Christian Church (Disciples of Christ) [AKA TFPCOM] – found online at www.kcdisciples.org/clergy by clicking on the *Theological Foundations & Policies and Criteria* button – provides a clear description of standing and how that is earned, affirmed, or removed. “Definition. Standing in the Christian Church (Disciples of Christ) is credentialing for ministry within the Christian Church (Disciples of Christ), a call to accountability to

the church, and collegiality with other ministers both denominationally and ecumenically.

a. Standing affirms that the Commissioned or Ordained minister is currently engaged in the practice of ministry, whether on an occasional, part-time or full-time basis, with continuous accountability maintained with a congregation, related organization or institution, Region, or General Ministry of the Christian Church (Disciples of Christ). Such ministers are listed in the *Yearbook and Directory of the Christian Church (Disciples of Christ)* and may call upon the church for services and support such as pastoral care, ecclesiastical endorsement, and scholarship aid. In addition, they have voting privileges in the General Assembly of the Christian Church (Disciples of Christ).”

WHAT IS DIFFERENT ABOUT REQUIREMENTS FOR RENEWAL OF STANDING IN THE GREATER KANSAS CITY REGION?

- **Every three years, Continuing Education in Healthy Boundaries/Pastoral Ethics must be completed, and information recorded on your Renewal of Standing Application.**
 - **Completion and recording are due by October 15th.**
 - Example: I completed an online course at the Lewis Center: *“Maintaining Boundaries in a Digital Age”* in September of 2021. By October 15 of 2023, I will need to complete a refresher course from among those listed on the Clergy web page for our Region if I plan to request renewal of my standing in 2024.
 - Setting healthy boundaries has been proven over and over again to help clergy steer clear of potential disruptions in relationships of trust. We have identified several ways for clergy to get an initial orientation to setting healthy boundaries or to participate in a refresher workshop. We continue to search for additional, affordable, and easily accessible opportunities for boundaries and pastoral ethics continuing education.
- **Every three years, Continuing Education in Antiracism must be completed, and information recorded on your Renewal of Standing Application.**
 - **Completion and recording are due by October 15th.**
 - Example: Rev. Smith, having already participated in a Reconciliation Ministry Anti-racism workshop in May 2019, took part in a Region-sponsored visit and group activity at the Greenville Rising Museum in Tulsa, Oklahoma on October 3, 2021. She will need to complete a refresher course from among those listed on the Clergy web page for our Region if she plans to request renewal of her standing in 2024.
 - By now anyone reading credible, peer-reviewed histories of the United States is familiar with the Doctrine of Discovery and the creation of a false racial hierarchy more than five hundred years ago to justify the taking of lands and resources; treating indigenous people as invisible or as commodities to be enslaved or otherwise abused. Even though most of us believe that systemic racism is in clearly opposed to the teachings of Jesus, the Church continues to be complicit – often by our inaction, indifference, and insularity. It has long been the consensus of our General Assemblies that leaders in the Christian Church (Disciples of Christ) should not only set better examples of ethical and equitable behavior, but our whole Church also needs to do the same. To meet this need

we agree to continue our professional education in a variety of ways at least once every three years for the privilege of standing renewal in this Region.

- **Forms of Professional Continuing Education**

- The highest priority for professional continuing education is to improve capacities for leadership in our ministries and contexts. We do not (at this time) have a syllabus since professionals usually know what they need and what will most benefit those they serve as well as add to the collective wisdom of the whole Church. What we do have is a collection of peer-reviewed resources and options that are shown to help us become better advocates and leaders in the Church's work of dismantling racism.
- Best continuing education practices assume that the professional first assesses what they need from a course, a workshop, a seminar, or independent study. When uncertain, arrange for a conversation with a trusted peer, supervisor or member of our Regional staff
- Typically, requirements for continuing education in healthy boundaries/pastoral care and antiracism are met in these ways:

- **Healthy Boundaries/Pastoral Ethics**

- Everyone starting out will benefit from a facilitated face-to-face workshop offered by the Faith Trust Institute. These last approximately six hours and they are offered at least once a year within our Region or in a Region nearby. Some ministers prefer this model and will participate in this workshop every three years.
- There are several online refresher courses offered by the Lewis Center and Safe Gatherings and links to those and similar courses can be found on our Clergy webpage.
- Participation in a healthy boundaries/pastoral ethics class offered by another church, institution of higher education or government or non-profit agency can be helpful for some ministers. Military coursework in this area also meets the requirement for standing renewal.
- Independent Group Study usually involves reading/viewing and processing with a small peer group what is learned. These should be led by a qualified facilitator so that the ensuing discussions about application of what is learned in one's ministry setting will be productive. Reading alone seldom results in a positive shift in attitude, practice, or habit. One way to add to the body of knowledge on the subject studied is for each participant to write a brief review of the material and its impact on the minister and to share that review with the Standing Committee so that this knowledge can help other ministers in their continuing education. A list of works recommended by clergy colleagues is found on our Clergy webpage.
- Clinical Pastoral Education units include reviews of best practices and fulfill the continuing education requirements for setting healthy boundaries.
- Ministers who prepare and teach a Safe Sanctuary program in their ministry context and who are willing to share their curriculum with our

Region may find this to be an especially rewarding and productive way to meet the continuing education requirements in one of their three-year cycles.

▪ Anti-Racism

- We highly encourage all ministers to have participated in at least one of the basic Reconciliation Ministry workshops offered at every General Assembly and periodically within our Region. Additional Reconciliation workshops are listed at <https://reconciliationministry.org> and include special focus areas like Winter Talk (which will be offered in the fall of 2022 in our Region).
- Participation in Transformative Community Conferencing train-the-trainer workshop is another way to build capacity for joining in the work of dismantling systemic racism in the Church and in the community.
- The [Kaufmann Foundation](#) hosts and [The Open Table](#) offers workshops designed to focus on an aspect of anti-racism work. When we become aware of them, we post notices in our Regional Social Media feeds and
- Regular participation in community organizing workshops nearly always involves anti-racism work, utilizing group dynamics and practices that promote inclusion and respect for participants who might otherwise be marginalized based upon the color or their skin or their zip code. - Regular service with our Region's Becoming Beloved Community Team requires that we continually evaluate planning for inclusion, greater awareness of systemic racism and its effects, and action to uproot causes of inequity in specific contexts.
- Independent Group Study usually involves reading and processing with a small peer group what is learned. These should be led by a qualified facilitator so that the ensuing discussions about application of what is learned in one's ministry setting will be productive. Reading alone seldom results in a positive shift in attitude, practice or habit. One way to add to the body of knowledge on the subject studied is for each participant to write a brief review of the material and its impact on the minister and to share that review with the Standing Committee so that this knowledge can help other ministers in their continuing education. - Ministers who teach or co-teach a class on antiracism using one of the recommended texts can both fulfill the every-three-year requirement and expand the circle of collaborators in their ministry setting.

- Update your online profile by or anytime before October 15 with any changes to your contact information, place of employment or ministry, and continuing education in healthy boundaries/pastoral ethics and/or anti-racism and indicate that you have reviewed and agree to follow the guidelines of the Ministerial Code of Ethics.

PROCESS TO APPLY FOR REINSTATEMENT AFTER LAPSED STANDING

- Complete and send or post online your application for renewal of standing
- Send a letter to the Standing Committee explaining why you allowed your standing to lapse and why you wish to have it renewed
- Your employer or chair/moderator/president of your congregational board should send a letter to the Standing Committee requesting reinstatement of standing

PROCESS FOR INACTIVE RETIRED MINISTERS TO APPLY FOR STANDING WITHOUT NEED FOR ANNUAL REAPPLICATION

STANDING RENEWAL CALENDAR – 2022

- January 2022
 - Letters indicating affirmation of standing are mailed along with standing cards for those who requested them
 - Letters indicating lapse of standing are mailed with copies to employers or board presidents/moderators
- May – October 2022
 - Opportunities for continuing education and clergy support events and activities will be frequently posted on Regional social media sites and in newsletters available to all Greater Kansas City Disciples.
 - Each posting will mention a reminder of the October 15 deadline for submitting standing renewal applications
 - *If you do not yet receive monthly emails or texts from our office with links to important information, contact Jessica Lopez, Office Manager at 913.432.1414 or office@kcdisciples.org.*
- June 2020
 - Letters to ministers and their ministry setting supervisors will be sent reminding ministers to fulfill continuing education requirements and to update their online ministerial profiles (or begin filling paper standing renewal forms which will be included in every packet).
- October 15
 - Deadline for updating online ministerial profile or mailing paper standing renewal applications.
 - ***Note: No reminders regarding potential lapse of standing will be sent in 2022. No applications for standing renewal will be accepted after October 15 without the approval of the Standing Committee. Applying for standing renewal annually is the sole responsibility of the minister. The Standing Committee and regional staff***

members will offer frequent reminders and offers of assistance throughout the year and the Clergy webpage will be updated and available at any time.

- November 2022
 - Standing Committee completes review of all submitted applications
- December 2022
 - Standing Committee recommends standing to the Regional Commission on the Order of the Ministry for all applicants who have met the criteria stated above.

SCHOLARSHIPS AVAILABLE TO CLERGY WITH STANDING

If you would like help fulfilling continuing education goals, there are many scholarships available to all GKC clergy with standing. Applications are required and funding is not guaranteed. Early submission and clear statements of purpose and learning objectives help to make applications more likely to be funded.
