Naples Beach Club Master Plan



Conservation Easement

- Naples Beach Club granted a Conservation Easement to the City of Naples and the North American Land Trust on October 29, 2024
- The Conservation Easement preserves forever 104.6 acres of the Naples Beach Club property including the property that comprises the 18-Hole Tom Fazio Golf Course and the Tennis Center as recreation and open space
- More than 84% of the property's 104.6 acres is restricted by the Conservation Easement
- The Conservation Easement area can never be developed commercially

18-Hole Tom Fazio Golf Course & Mary C. Watkins Tennis Center Improvements

- No change in the number of golf holes (18-holes)
- Enhanced Practice Range in existing location
- Addition of Short-Game Practice area, a 9-Hole Putting Course and a Practice Putting Green
- No change in vehicular access or curb cuts
- New contoured golf course with enhanced variations in elevation and enlarged reconfigured lakes
- Enhanced lake system improves the stormwater on-site storage by 496% over city requirements
- Refinement of golf cart path network to improve circulation
- Enhanced landscaping to improve the aesthetics of the golf course perimeter
- New facilities: Range House (Pro Shop & Snack Bar), Golf Comfort Station, Storage Building, and Pump House
- Renovation of existing tennis Pro Shop
- Renovation of 6 existing tennis courts, including new Har-tru surfaces
- New 20 space parking area behind the Tennis Pro Shop





Contiguous Open Space Impervious Area

PERPETUAL EASEMENT AND DECLARATION OF RESTRICTIONS AND COVENANTS

3.2.1 (e) The following improvements with a maximum aggregate ground coverage area of all such improvements not exceeding 4.2 acres¹⁰ (182,952 square feet at any time): (1) impervious golf cart paths, (2) impervious pedestrian walkways and sidewalks, (3) impervious roads serving allowed uses within the Easement Area, and (4) one building for sanitary facility and refreshment (a "comfort station"); provided, however, that the comfort station within the Contiguous Open Space Area, if more than 1,000 square feet in ground coverage area, shall not be located within 200 feet of any residential property that is outside the Property or separated from the Property by a public street.




Naples Beach Club | Golf & Tennis Facility Setbacks & Permitted Uses

US-41 (Tamiami Trial) Proposed Berm Construction

- Prior to the commencement of the Golf Course construction, Naples Beach Club is proposing to build a permanent protective berm along US-41 (Tamiami Trial) following Preliminary Design Review Board Hearing approved landscaping plan. The berm will be designed with professional irrigation system and stormwater control structures.
- Berm to be initially graded to keep Haul Road in place at entrance along US-41 (Tamiami Trial).
- After removal of construction Haul Road, the berm will be completed per final Design Review Board Hearing approved plan.
