Our Savior's Lutheran Church Foundation distributes funds in support of the programs, activities and missions of Our Savior's Lutheran Church of Lake Oswego, Oregon. The programs should support the vision of Our Savior's Lutheran Church, the growth of its community, and work to achieve social stability in our local community and communities supported by Our Savior's Lutheran Church.

Requests for funding will be considered from OSLC internal programs or projects and external programs or projects where OSLC has a vested interest. The Foundation does not fund general operating expenses. If an applicant received prior grant funding, a follow-up report detailing the results of the project must be submitted prior to receiving future grants. Recipients of grants will be required to permit the Foundation to publicize their organization name and project information.

Note: Please limit your application to no more than four (4) pages. No exceptions. Please do not include any supplemental information other than what is requested.
