***You may be eligible for PRC services if you are a family with a minor child(ren) in the household and meet certain income guidelines.\****

## COVID-19 Emergency Services

Licking County Job & Family Services is offering specific emergency services for eligible Licking County families impacted by COVID-19.

If you have experienced unexpected household expenses related to the coronavirus/COVID-19 crisis and meet family composition and income standards (at or below 200% of the federal poverty guideline), you may be eligible for COVID-19 Emergency PRC. Priority will be given to expenses related to preparing for or involvement in self-quarantine and social distancing. Other services include assistance with rent, housing deposits, utilities, mortgage, car payments, and car insurance.

***You may be eligible for COVID-19 Relief Fund services if you are a single adult or couple without minor children in the household, have experienced a job loss or wage reduction related to the pandemic, and meet certain income guidelines.\****

If you have experienced a job loss or wage reduction directly related to the COVID-19 Pandemic, are a single adult or couple without minor children in the home, and are at or below 200% of the federal poverty guideline, you may be eligible for Licking County COVID-19 Relief Fund services. Priority will be given to expenses related to preparing for or involvement in self-quarantine and social distancing. Other services include assistance with rent, housing deposits, utilities, mortgage, car payments, and car insurance.

# Senior/APS COVID-19 Services

***You may be eligible for Senior/APS Covid-19 services if you or your spouse is a senior citizen (60 years old +), are at or below 200% of the federal poverty guideline, and experiencing a financial hardship due to the COVID-19 Pandemic .\****

## Senior/APS COVID-19 Services

Licking County Job & Family Services offers Senior/APS COVID-19 Services to help seniors maintain self-sufficiency and avoid dependency.

If you or your spouse is a senior citizen (60+) who is at or below 200% of the the federal poverty guideline, have experienced unexpected household expenses related to the coronavirus/COVID-19 crisis, and needs assistance to maintain self-sufficiency and to avoid dependency, you may be eligible for Senior/APS COVID-19 Services. Priority will be given to expenses related to preparing for or involvement in self-quarantine and social distancing. Other services include assistance with rent, housing deposits, utilities, mortgage, car payments, and car insurance.
