Contributions to Cooper Victory Fund will be allocated as follows: The first \$7,000 of each contribution from a person and the first \$10,000 from a multicandidate committee ("PAC") will be allocated to Cooper for North Carolina. The first \$3,500 of a person's contribution and the first \$5,000 of a PAC's contribution will be designated for the primary election; the next \$3,500/\$5,000 will be designated for the general election. The next \$10,000 from a person and \$5,000 from a PAC will be allocated to North Carolina Democratic Party - Federal. The next \$44,300 of a contribution from a person and the next \$15,000 from a PAC will be allocated to the DSCC General Fund. The next \$132,900 from a person and the next \$45,000 from a PAC will be allocated to the DSCC Headquarters Fund.
