

# VAA AUCTIONEERS CHAMPIONSHIP REQUIREMENTS

**TIME & LOCATION OF CONTEST** | The Virginia State Auctioneers Championship will begin promptly at 6:00pm on Saturday, January 11, 2020 at the Lansdowne Resort and Spa in Leesburg, VA.

## ELIGIBILITY OF CONTESTANTS |

Any auctioneer licensed by the state of Virginia who practices the profession of auctioneering in the State of Virginia is eligible to participate in the contest. You must be a VAA member and you must reside in the state of Virginia to participate. Both officers and directors of the Virginia Auctioneers Association and members of the committee are also eligible to compete in the contest.

## ENTRY FEE AND CLOSING DATE | The registration fee is \$50.00 for each contestant.

**PERFORMANCE ORDER AND APPEARANCE** | All contestants should be dressed appropriately. Each contestant will appear on the program in the REVERSE order the entries were received (first entries will sell last). Auctioneers who sign up the day of the contest will sell before those who pre-register. Each contestant must appear as his or her number is called by the master of ceremonies. Any contestant failing to appear in the assigned order will receive a 10-point penalty and shall appear at the next opening as directed by the master of ceremonies. You will be selling your item plus other supplied items, if necessary.

### CONTEST PROCEDURES | Each contestant is asked to bring three (3) items with a minimum value of \$25/each.

On the first round, the top-scoring contestants will be invited to participate in the finals. In case of a tie, those tied will be eligible to participate in the finals. Immediately following the first round, the top scoring contestants will sell again for the finals. The event organizers will provide items to be sold in the finals.

### JUDGES AND JUDGING | There will be a minimum of 3 judges for the contest. Each judge will score in all categories.

The categories scored shall be: Presentation, Chant/Voice, Effective Auctioneering and if you would make a good ambassador for the VAA. In the finals there will be an additional category added for the interview portion. Copies of the scoring sheets being used will be sent along with the Champions packet approximately two weeks before the date of the contest. Individual score sheets will be mailed to the contestants after the contest.

## AWARDS

**1st Place** receives the Champions Award for one year along with a trophy to keep and a Champions Ring

**2nd Place** receives a trophy

**3rd place** receives a trophy
