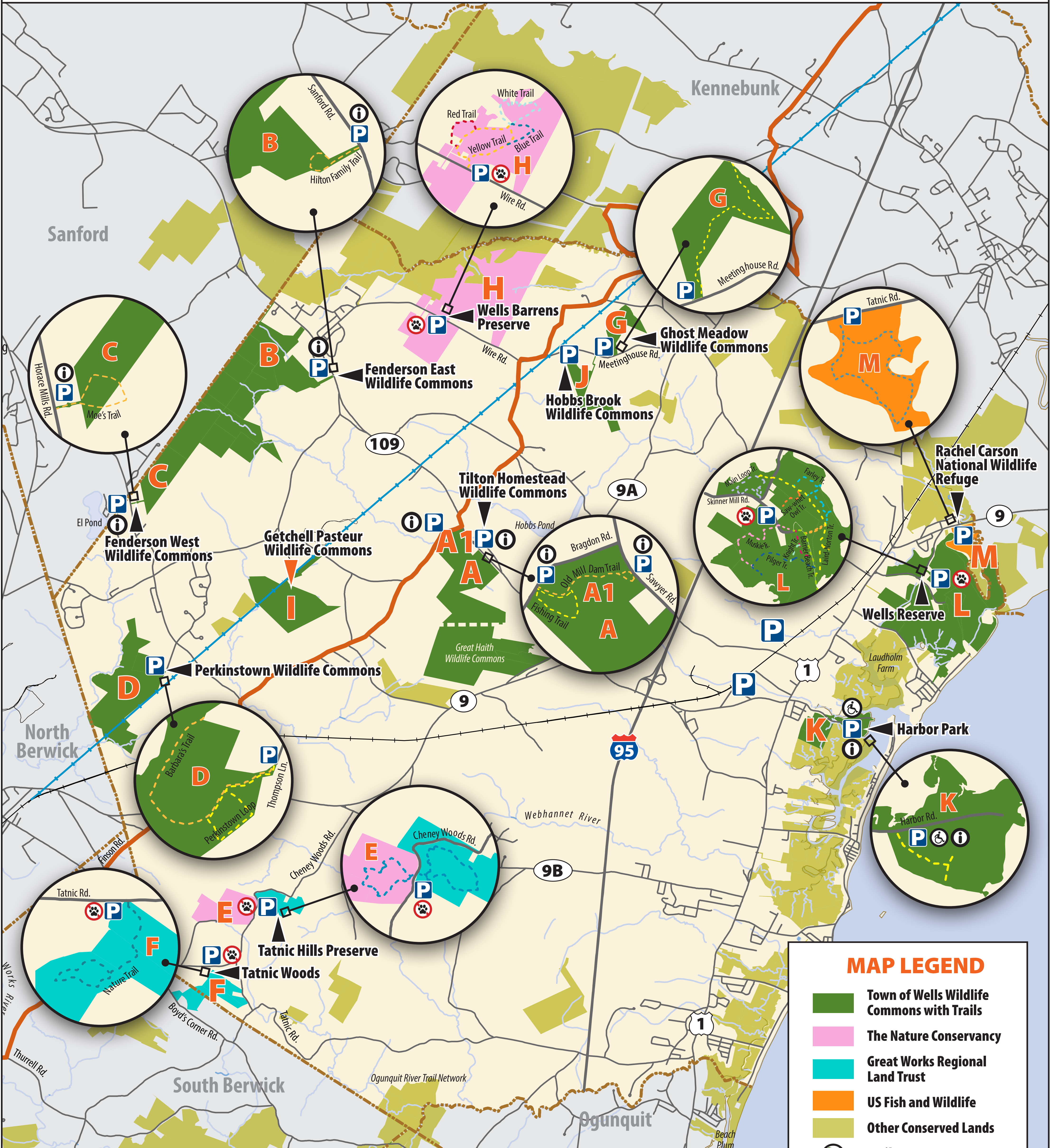


WELLS CONSERVATION COMMISSION HIKING TRAILS

- A** – Tilton Homestead Wildlife Commons | Old Mill Dam Trail, .3 mi | Fishing Trail, .3 mi | Trail head and parking located at 99 Bragdon Rd. | Owned by Town of Wells
- A1** – Tilton Lot | 5.5 acres with homestead | Parking located at 131 Sawyer Rd. | Owned by Town of Wells
- B** – Fenderson East Wildlife Commons | Hilton Loop Trail, .6 mi | Beaver Dam Trail, .6 mi | Trail head and parking located on Route 109, 2507 Sanford Rd. | Owned by Town of Wells
- C** – Fenderson West Wildlife Commons | Moe's Trail, 1 mile loop trail | Trail head and parking located at 335 Horace Mills Rd. at town line | Owned by Town of Wells
- D** – Perkinstown Wildlife Commons | 288 acres with 2 miles of trails | Barbara's Trail, 1 mile | Perkinstown Loop, .5 mile | Trail head and parking located at 96-98 Thompson Ln. cul-de-sac (off Perry Oliver Rd.), Wells | Owned by Town of Wells
- E** – Tatnic Hills Preserve | 158.95 acres | 2 trails | 0 Cheney Woods Rd., dirt road | Owned by Great Works Regional Land Trust and The Nature Conservancy
- F** – Tatnic Woods | 27.2 wooded acres, rich in vernal pools, with 1 mile of trails | Trailhead and parking located at 2460 Tatnic Rd. | No dogs allowed | Owned by Great Works Regional Land Trust
- G** – Ghost Meadow Wildlife Commons | 48.53 acres | Trails being developed | 1263 Meetinghouse Rd. and 351 Clark Rd. | Owned by Town of Wells
- H** – Wells Barren Preserve | 332.11 acres | 4 trails | Parking located at 514 Wire Rd. | No dogs allowed | Owned by The Nature Conservancy
- I** – Getchell Pasteur Wildlife Commons | 141.6 acres | No trails | 234 Bill's Ln. | Owned by Town of Wells
- J** – Hobbs Brook Wildlife Commons | 70 acres | No trails | 1090 Meetinghouse Rd. | Owned by Town of Wells
- K** – Harbor Park | 40 acres | 352 Harbor Rd. | Webhannet Marsh Trail, 2 mi. | Owned by Town of Wells
- L** – Wells Reserve Trail Systems | 242.96 acres | 55 Skinner Mill Rd. | Large parking lot | Owned by Town of Wells
- M** – Rachel Carson National Wildlife Refuge | 26.2 acres | 321 Port Rd. on Route 9A East | Owned by U.S. Fish and Wildlife
